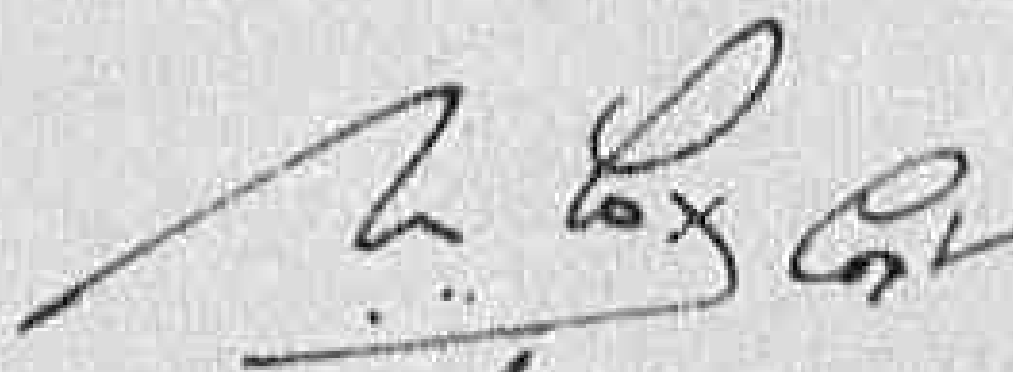

He was recently married in the U.K. but his conduct suggests that he does not take this very seriously, and I think it would be to the man's own interest if he could be posted to a larger unit where he would be more fully employed, and where he would have less individual freedom than he enjoys in a small unit of four O.Rs.

It is also apparent that he is an entirely different type of man as regards education and outlook on life to the rest of the unit (who are the only British troops in Palermo) and whereas in a larger unit he would probably find kindred spirits, it is possible that his present situation gives rise to a certain amount of loneliness which may affect his conduct.
