1. With effect 19 Dec the Petrol Point at POGGIORNALE closed and reopened in CASERTA.
2. Vehicles in transit requiring Petrol in the NAPLES Area will draw from CASERTA Petrol Point.
3. Should Petrol be required in NAPLES itself authority will first be obtained from OC Troops NAPLES Area, Tel No 20465 located at No 9 Via del CRISTO, NAPLES (rear of bombed out corner of civilian Post Office). It is necessary to produce AF G.5516 (Work Ticket) correctly completed together with copy of Movement Order showing reason for their visit to this Area.
4. Authority can only be given for the issue of petrol in Unit quantities of 4 gallons.
5. On receipt of duly signed authority from OC Troops, transit drivers will be able to obtain petrol from the Napfs Installations (CIP) at the NAPLES end of the Autostrada. Map reference 252497.
