CINGARI Carmela daughter of Panrazio and of Di Biasi Assunta, born in Taormina on the 24th of Feb. 1923, residing in Vico Cieco - Via Ginnasio - Taormina is of good moral, civil and political behaviour.

In 1944 she was engaged to Finocchiaro Francesco from Calatabiano, with whom she lived as his mistress for about 6 months, but just before getting married, Finocchiaro proposed to take Miss Cingari to S. Teresa Riva for business reasons. The mother of Miss Cingari was opposed to this, and Finocchiaro on the 2nd of July 1944 went to Calatabiano and committed suicide.

Since then Miss Cingari remained with her mother working at home without giving any trouble.

She was never Nazi or Fascist and has always lived in Taormina, even during the war.

"In reply to your telegram, we inform you that CACCIOLA Adele, daughter of Giovanni and Cataliano Teresa, born in Messina 12.8.1924, living in Via Centonze 222, is of a good moral, civil and political conduct, no crimes resulting in the local Judiciary Department on her account. She is good hearted. The same can be said of her parents, with exception to the following ones, on whose account result some crimes:-

father - CACCIOLA Giovanni - dead - 9.11.1938 Messina Court accused for concubinage and violence, obligations familiar assistance, but the sentence was recited.
mother - CATALIANO Teresa - 20.9.1931 Messina Court condemned to pay 300 lire mulct for verbal injuries, 25 days prison for voluntary personal wounds; 10.9.1931 Messina Court absolved for remission of injuries complaint; 21.6.1939 Messina Court 100 lire mulct for offense to 86 Article of P.S. Law.
