1. The following suggestions are forwarded in connection with the care and maintenance of Mechanical Vehicles, with the recommendation that they be implemented immediately.
2. It is not stated how often it is proposed to hold the competition, but it is suggested not more than once per month, otherwise a certain number of personnel will be tied up for a considerable period. The Committee could meet regularly on the same days each month.
3. It is also suggested that when judging a vehicle, the A.B.406 record should be taken into account, when awarding marks, and not just the appearance of the vehicle at the time. This would show how the vehicle came out in platoon and workshop inspections for that month. The manner in which the A.B.412 is kept can also be considered.
4. It is considered that stress should be laid on the fact that it is not only the promise of a prize that should encourage good maintenance. It is the responsibility of the platoon commander or M.T.O. to ensure good maintenance and to "stimulate" interest if necessary.
5. An understanding should be obtained from the Comando Scuola that the competition inspections do not, to any degree, take the place of regular bi-monthly A.B.406 inspections.

Divisions-, to the Italian Army, all the necessary repairs will be carried on as follows:-

- 1) - All small repairs to be done by the Divisional Work-Shops .
 - 2) - All the more important repairs to be done by the O.A.R.E. of Bologna
- Directions for the necessary equipment of the O.A.R.E. hve been given to the competent Authorities.

To facilitate the starting of repairs, by the O.A.R.E. all the Inf. Commandos as well as the Comando Scuole, have been ordered to appoint, each of them, a specialized Storekeeper having a good knowledge of spare parts for Allied vehicles.

One more specialized Storekeeper to be sent to Naples to the 557 Base Ori. Depot, to form a Section of personnel capable of identifying all the spare parts that will be asked for by the O.A.R.E..

The Ministry of War suggests that with reference to above personnel special agreements should be previously taken with the B.I.U. informing same that the aform. specialized personnel has been requested by R.E.M.E. a Branch of M.M.I.A..

1. The attached report from O.C. 155 Workshops (signature and rank illegible) brings to light a most flagrant case of canibalisation on which I feel most strongly. I notice you wish to do everything possible to prevent this practice and I shall be obliged if you can let us know what steps you think are best to ensure the offenders are suitably punished, and to prevent a recurrence.

2. I am informed this morning that 638 Workshops (British) are no longer prepared to receive any work from Italian sources, and hence it would appear our own 155 Workshops will have to assume responsibility for all repairs. This makes it all the more important that orders you have already issued as to the proper procedure for sending vehicles into Workshops should be strictly adhered to. It is obviously impossible for the commander of the Workshops to properly organise his work if vehicles are sent to him without proper authority or notice.




1. As the PTOENO Division now no longer exists I suggest that the present signs be removed as obsolete and confusing.
