The remainder of the fuse and shell remained normally holding the usual airburst pattern vertically at 5537 feet. No useful pieces of shell or fuse were discovered, but the search is being continued.

Rounding in this detachment had not been good, but the low elevation (5000 yards Ch.II) was not such as to permit of "slipping back". There was no reason to suppose the individual had not engaged, for the running was not fast.

Injury.....One Italian Gunner (No.5), received a slight flesh wound, immediately dressed by the M.C. and termed "not serious".

Damage ....Barrel L/16704 sustained damage to nozzle by solid metal of shell, and interior damage to lands by the ricochetting shell base cylinder.

Appendix "A" to A.M.O. 590 is being completed and will follow in due course, unless this office is notified of any core research programme to be used.

Capt.(I.C.) J. Elwyn Gullick R.A., was near the gun and witnessed the occurrence.

Although nearly 300 more fuses and shells of the same or similar lots were subsequently fired from the remaining guns, no further occurrences were experienced.




