1. It will be noted that the above letter does not provide for an initial issue of shaving soap but only for a maintenance issue of one stick per man per four weeks.
2. In order that each man at HNS HQ may receive an initial issue of one stick of shaving soap, authority is given under reference 121/256/2/134 dated 24 April 45 for such an issue up to a maximum of 15,000 sticks for the month of April, and thereafter at the rate of 5,000 sticks per month to provide for the intake of new personnel on arrival at HNS HQ.

1. Reference your Ho 07/2078/S/Case dated 11 July 45 with attached report on the deficiency of RFI Supply received from 37 BLS.
2. 37 BLS have been approached on the subject of the shortages discovered in the supplies drawn by you on the 4 June 45, but it is regretted that no credit can be allowed as requested in your letter.
3. As is pointed out by 37 BLS there is a notice displayed on the issue counter to the effect that it is the responsibility of the receiving unit to check the quantities of items as issued.
4. The losses were discovered according to your report on the 4 June and reported to this H.Q. on the 16 July. It is not felt to be reasonable that 37 BLS should accept responsibility for shortages reported five weeks after discovery.

1. The July entitlement of MPI supplies for HVC ICE was drawn from 37 MIS on 20 August. These supplies have always been drawn by HVC ICE one month in advance.
2. In order to conform with HVA Letter 0/2/3 dated 31 July, which stated that MPI supplies to the Italian Forces would cease on 1 September, HVC ICE called to collect the August entitlement on 30 August but were refused issue.
3. It would appear that there was some misunderstanding at 37 MIS where it was stated that the issue of supplies to Italian Forces had already ceased.
4. The latest HVA August entitlement was forwarded to 37 MIS by HVC ICE under reference 07/2495/3/Comm dated 7 August.
5. HVC authority therefore please be drawn for the balance of the August entitlement by 37 MIS. If you will notify this H.A. when the items are available arrangements will be made for immediate collection.

2. Authority AFHQ 2554/Q(Maint) dated 13 Sep. This authority must not be quoted as a precedent for the issue of toilet articles to other BR-ITI troops. The scale given is the maximum possible.

3. These items are additional to those notified in this HQ Q 242 dated 1 Sep under authority AFHQ 2554/Q(Maint) dated 26 Aug (copy attached for CMF Depot).
