Subject: P.T. School. -

1. - As ~~it is~~ known, the P.T. School is not in a position to carry out efficient activities during the winter period owing to the precarious conditions of ~~the school installations~~ at Cesano, the repair of which is not convenient due to the foreseen transfer of said School to Rome as soon as possible. Therefore, the 6th normal course for P.T. instructors ~~of Corps and Units~~ cannot commence before the 15th February 1947, in accordance with executive instructions to be issued later.

2. - The period 15 Nov.- 15 Feb. will be used:

stated a) for the carrying out of a refresher course for permanent staff instructors of the School according to the ~~instructions~~ ^{procedure} of para 3 below;

b) for the compiling of the programme for the carrying out of the 6th normal course, improving and enlarging the one at present in use;

c) for the internal requirements of the School (revision of the teaching, P.T. and sports equipment, leave for the permanent staff, etc.). -

3. - Refresher course for permanent staff instructors:

- purpose: to improve the teaching, P.T. and sport capabilities of the instructors - to train specialist instructors for several branches of sport activities (athletics, boxing, etc.)
- commencing: 18th November 1946
- duration : 4 weeks
- personnel attending the course : P/S. Officer and NCO instructors and also the personnel detailed by this S.M. ~~with~~ letter 6509/L/1 dated 18/10/46 addressed to the Central Military Schools HQ.

- Total: approximately 15 Officers and 15 NCOs. -
- Location: Rome, using the gymnasiums and sport fields of the various federations and societies as per agreements made with the School HQ.
The personnel attending the course will be billeted, during the course, in the premises of the Police School according to instructions to be issued by you.
 - No indemnity will be granted to P/S. Officers and NCOs of the P.T. School during their stay in Rome, as the seat of the School will remain at Cesano.
 - We beg you to forward ~~us~~ a copy of the ~~hourly programme~~ ^{TIMETABLE} of the course. -
