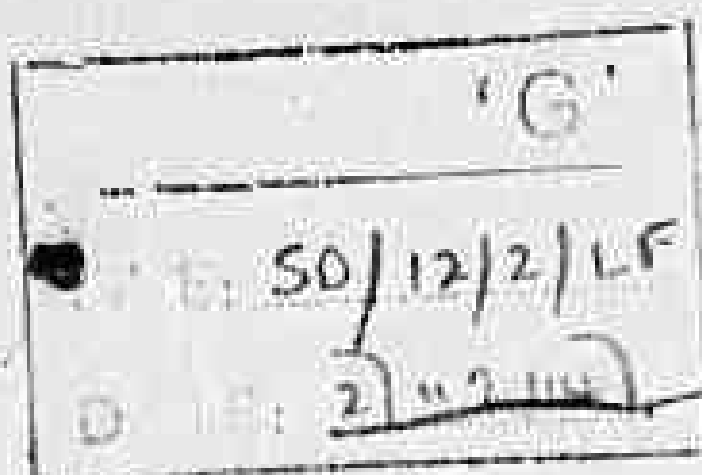

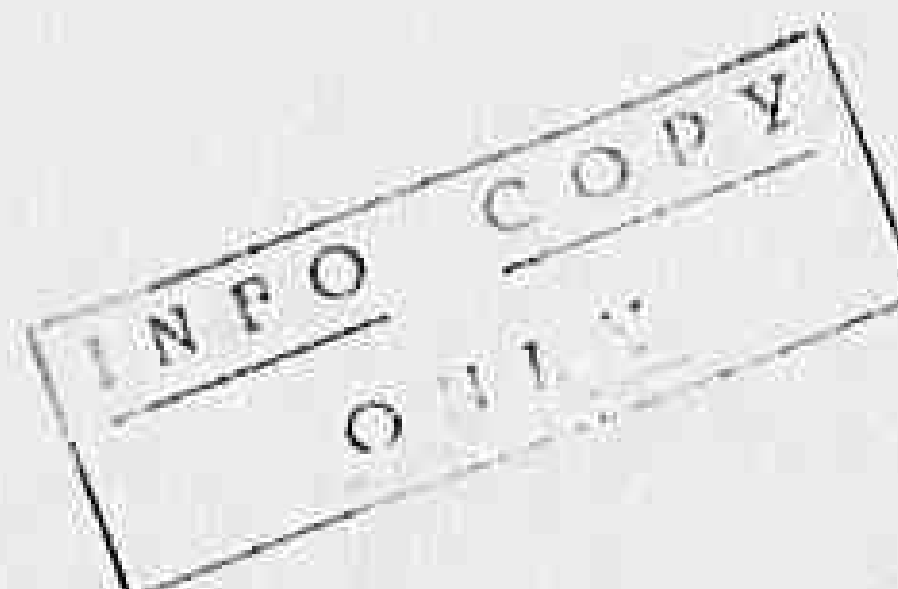

1. Reference your 18225/3-3(Tr) dated 13 May 46 and telephone conversation Major Benford/Major Anderson, a certificate of completion of the disbandment of the 83rd Italian Evacuation Hospital has been delayed as the two vehicles (3-ton and 15-cwt. respectively) are at present in a B.L.R. condition in this Headquarters' Workshop.

2. A letter has been forwarded to GSO 1 of G. Workshops enquiring if it is possible to land the vehicles direct into their Workshop in view of the fact that this unit is unable to supply drivers for them as there are no vehicles available with which to tow them to 17 R.V.P. Milan and 18 R.V.P. Carrara, respectively.

3. The personnel were disbanded immediately and transferred to other units, but Accommodation Stores etc., have been retained at the Grande Scuola Centrali Militari on instructions from Ordnance M.K.I. who, it is understood, have made the necessary arrangements with Ordnance R.A.A.C.

4. The delay in rendering the completion certificate of disbandment is very much regretted by this Headquarters, but it will be seen that in view of the fact that arrangements were in progress for the retention of stores and the return of the vehicles, it was not considered advisable to render the necessary certificate until the full transaction had been completed. When further information becomes available with reference to the disposal of the two vehicles you will be informed accordingly.

- 5°)- All previous names with corresponding numerations are cancelled.
- 6°)- Any deficiencies or excess of military personnel, in application of that laid down for the W/Es referred to in the publication I3/S will be reported, in accordance with present instructions to the departments concerned at this ministry, for arrangement to be made to settle the deficiencies and for the employing of the personnel in excess..
- 7°)- The same reports will be made to this ministry S.M.R.E.- Service Office as far as transport is concerned.
- 8°)- Also concerning civilian personnel, the instructions contained in cir. N° 886/Ord/II dated 26/2/46 remaining the same, it is necessary to reach as soon as possible, and anyway not later than the 30/6/46, the figures laid down for each department.
- 9°)- Any detailed instructions will be given by the Mil. Health Gen. Dir.
- 10°)- Commissariat Service Gen. Directorates and Admin. will issue the necessary instructions for the change, where necessary, of the present allocation of rations.
- 11°)- Mil. Terr. HQs concerned, when the accommodation of the service has been completed, will inform this S.M.

It is not necessary to forward the usual lists for the approval of the forming of the departments shown in the enclosures of this circular.

1. Since the W.E. strengths of Refugee units (page 79 of your Orbat 2/12) totals 1020 officers and ORs, and the actual strength is approximately only 700 there would appear to be no difficulty in the inclusion of Italian nurses within the authorized W.E. numbers for ration purposes.

2. May it be confirmed, please, that provided the sum total of Italian nurses plus Italian troops is kept with W.E. TOTALS, the issue of Italian military rations to these nurses will be in order.

3. If this is not agreed, it is presumed that the ceiling for Refugee units will need increasing by the number of Italian nurses employed.

4. The personnel carried against the ceiling of 3000 has recently been varied as under:-

→ Reduction 43 officers 894 ORs - 1 Truck Bn.
Addition 40 officers 150 ORs - Tucker Camp

There is therefore a vacancy on ceiling strength for 3 officers and 744 ORs which will more than cover the regulated addition of a maximum of 100 nurses, 5 to each camp staff, excluding HQ.
