This unit was formed in October 1943 as part of the newly constituted Italian General Staff in BRINDISI, to work under the direct operational control of the Allies in a counter-intelligence role. This control was relinquished by the Allies and handed back to the Italian General Staff on 15 August 1946.

2. Identification.

As control of the unit has been returned to the Italian Army, it is now known as the 2 Sezione of the Italian Ufficio "I", although it still retains the title SOE Independent Unit. It now forms an integral part of the Italian Army Intelligence organisation and works explicitly for the Italians, although strict liaison with all Allied intelligence agencies is maintained throughout Italy.

Since its formation, this unit has been engaged on counter intelligence duties generally, including counter-spying, counter sabotage, internal security of Allied forces, morale etc. These functions continue to represent the employment of SOE independent unit of the Italian Army Intelligence. Its work was directed and controlled by AFHQ in ITALY, until control of the unit was passed to the Italian Authorities.


1. With the easing of tension now that the elections are over, and the clearing up of the GIS network in Italy, it is felt that the time has come for the Italian Army to reassume control of the 808th SC Battalion, which up to now has been under the operational control of AFHQ.

2. This unit has rendered very valuable assistance in the past, and it is desired that such assistance should continue while Allied Forces remain in Italy.

3. It is thought, however, that direct liaison at all levels with the local Allied security services will achieve this purpose, and that it is no longer necessary for AFHQ to maintain operational control.

4. Accordingly, it is requested that the Italian Army reassume operational control of the 808th CS Battalion w.e.f. 15 August 1946, subject to the conditions set out in paragraph 3.






