The possibility of resorting to recalled personnel being excluded for known reasons, we notify the new requirements in order that M.M.I.A. may lay down from which units the personnel may be drawn. As far as the CC.RR is concerned it will be necessary to increase the quota of 1850 men at the disposal of the Army, which quota, as is known, is fully occupied on duties strictly pertaining to the activities of the units.

1. I refer to your memorandum of 13 May 45 setting forth the conditions under which you propose German POW's might be made available for employment in Italy. The question has been discussed with the Italian Government in some detail but at the moment it would appear that the number of prisoners they wish to employ is only about 20,000. In a letter which I have received from the Prime Minister dated the 9th June, he proposes that they be disposed as follows:-

3. I request therefore that you set up such reconnaissance parties and that you include the following:

- (a) Representatives of the Branch or Branches of AFHQ who will be responsible for administering and maintaining the prisoners.
  - (b) Representatives of the Italian Ministries of Industry, Commerce & Labour, Agriculture, Public Works and War according to the nature of the work project under examination.
  - (c) Representative of M.M.I.A. who will have to make the arrangements with the Italian Ministry of War for the supply of the necessary guards.
  - (d) Representative of the Allied Commission.
4. It should be possible to carry out a number of the reconnaissances simultaneously and I should be glad if you would agree to them being commenced at as early a date as may be possible.

2. INTRODUCTION.

a. Brig. Gen. TATE drew attention to the minutes of the meeting held at BOLOGNA on 7 May 1945, which considered the Final Concentration Area for surrendered Enemy Forces. These minutes were circulated for preliminary study by all present.

b. Fifth Army has been charged with responsibility for initial concentration of all surrendered forces of Army Group "C", wef 0001 hours, 13 May 1945. This task was given Fifth Army because the bulk of the surrendered forces is in Fifth Army's sector, and Eighth Army is engaged in occupying VENEZIA GUILA and southwestern AUSTRIA.

c. Fifth Army is now engaged in concentrating surrendered forces in initial concentration areas. This task is about completed. It is now necessary to move enemy troops to final concentration areas.

d. Following is estimate of surrendered forces and PW in the area under control of Fifth Army:

e. Instructions from AFHQ have stated that US and British will assume equal responsibility for surrendered forces in the Final Concentration Areas. No. 1 District will be responsible for the Final Concentration Areas for surrendered forces under British control, and the area BRUNN - CESENA - CERVIA has been selected. No Final Concentration Area for surrendered forces under US control had yet been chosen, nor had the Headquarters which will be responsible for such area, yet been designated. The area north of BOLOGNA selected from the map prior to 9 April 1945, had been abandoned as unsuitable.

3. CLASSIFICATION OF ENEMY PERSONNEL AS PW OR SURRENDERED FORCES.

a. Major General MACLEOD stated that in their JAN 331 the combined Chiefs of Staff had made it clear that PW could be reclassified as surrendered personnel, if required. MTOUSA said they were not previously aware of this ruling.

b. As a general uniform principle it was agreed that PW in the Army areas, who were disorganized and could not be reorganized into their units, would be evacuated to base as PW. Organized units and as many personnel as could conveniently be reorganized into units could be reclassified as surrendered personnel and put in the final concentration areas.

c. The 40,000 PW of Eighth Army have now almost completely been evacuated to 1 District. These are largely disorganized and, with the exception of any organized units, will be evacuated to Base on a phased programme to be agreed between AFHQ and 1 District.

e. Instructions from AFHQ have stated that US and British will assume equal responsibility for surrendered forces in the Final Concentration Areas. No. 1 District will be responsible for the Final Concentration Area for surrendered forces under British control, and the area RUMINI - QESINA - GERVIA has been selected. No Final Concentration Area for surrendered forces under US control had yet been chosen, nor had the Headquarters which will be responsible for such areas yet been designated. The area north of BOLOGNA selected from the map prior to 9 April 1945, had been abandoned as unsuitable.

### 3. CLASSIFICATION OF ENEMY PERSONNEL AS PW OR SURRENDERED FORCES.

a. Major General MACLEOD stated that in their PAN 331 the combined Chiefs of Staff had made it clear that PW could be reclassified as surrendered personnel, if required. MTOUSA said they were not previously aware of this ruling.

b. As a general uniform principle it was agreed that PW in the Army areas, who were disorganized and could not be reorganized into their units, would be evacuated to bases as PW. Major General WHITE stated that SHAFT Disbandment Directive No. 1 planned for the early return to Germany of key personnel for industry and agriculture. AFHQ will issue an instruction for registration of such personnel to take place in the Final Concentration Areas. This will not apply to SS or non-German personnel. SHAFT are being informed of our action, but otherwise nothing firm can be stated.

5. SELECTION OF CONCENTRATION AREAS - GERMANY VIENNA.

a. Brig. Gen. DATE read for information a memorandum submitted by the German G-in-C Southwest requesting that concentration should take place in the South Tyrol on the principal grounds of:

- (1) Avoidance of move of hospitals.
- (2) Available accommodation.
- (3) Better climate.
- (4) Hostility of PO Valley population.
- (5) Threat of desertion becoming uncontrollable in event of move.

It was decided to ignore this request.

6. SEPARATION OF GERMANS AND ITALIANS IN FINAL CONCENTRATION AREA.

Only about 3000 Italians are now held. These will be kept separate from Germans and will all be held under US control, but will count against the overall allocation of surrendered forces as between US and British.

c. CSO, 15th Army Group, stated there would be a requirement for employment of certain signal construction units under CSO L of C. It was agreed that if possible these should not be brought into the Final Concentration Area, but would be counted against the British allocation and be a British commitment. OSO undertook to give further details of the units required.

20. DISPOSITION OF SURRENDERED FORCES IN PRESENT EIGHTH ARMY ZONES OF ACTION.

Eighth Army are holding some 40,000 Germans and 50,000 Cossacks, of which latter 20,000 are women and children, in their present Zone of Action. GAO has been informed and has stated that AFHQ will issue a policy decision on disposal. Meanwhile Eighth Army will be responsible for maintenance of these personnel.

At this point the British representatives withdrew and the conference was continued under US auspices only. The following policies and decisions are recorded.

21. DISPOSITION OF SURRENDERED PERSONNEL IN HOSPITALS.

Fifth Army will retain responsibility for guarding and administration of non-transportable German sick and wounded in hospitals from North of VERONA to the AUSTRIAN border and will receive credit for such personnel surrendered. Transportable patients will be sent to final concentration areas on a 50-50 basis.

22. DISPOSITION OF US POSITION OF SURRENDERED FORCES.

- a. It was announced by G-1, MCUSA, that General MCNAULY had decided there would be no centralized concentration of PW and surrendered enemy personnel under U.S. control. An interim area for staging the surrendered personnel South and Southwest of Brescia will be established by Fifth Army until final disposition of surrendered and PW personnel can be effected. It is the plan of MCUSA to put all Germans (both PW and surrendered personnel) to work so as to release, at an early date, personnel of the Italian PW Service Units and Italian Military Service Units now under US control. Italian troops number some 100,000. The German personnel will not be used to supplement the Italian PW or military personnel in truck units and military police units. In addition an offer has been made to the Italian Government to lend them such German personnel as they may be able to use in the reconstruction of Italy. **1072**

- b. Responsibility for the administration and guarding of German personnel is being withdrawn from the Provost Marshal General of MCUSA and is being placed in the hands of General BOLTE, US 34th Division Commander. General BOLTE's responsibilities will be two fold. One: To continue control, classification and the formation of required units from German PW and surrendered personnel.

At this point the British representatives withdrew and the conference was continued under US auspices only. The following policies and decisions are recorded.

21. DISPOSITION OF SURRENDERED PERSONNEL IN HOSPITALS.

Fifth Army will retain responsibility for guarding and administration of non-transportable German sick and wounded in hospitals from North of VLAOINA to the AUSTRIAN border and will receive credit for such personnel guarded. Transportable patients will be sent to final concentration areas on a 50-50 basis.

- b. Responsibility for the administration and guarding of German personnel is being withdrawn from the Provost Marshal General of MTOUSA and is being placed in the hands of General BOYD, US 34th Division Commander. General BOYD's responsibilities will be two fold. One: To continue control, classification and the formation of required units from German PW and surrendered personnel.
- c. It was emphasized that classification of German personnel by civilian occupation must proceed as rapidly as possible. General MCNAULY has directed that conversion of the units must not require longer than six weeks. This time limitation is necessary in order that staging areas at PBS can be cleared for redeployment of troops. Some 90,000 German personnel must be provided for by that time in order to clear these staging areas. The German personnel will take over the equipment and the accommodation now being utilized by the Italian units. When the conversion of an Italian unit has been accomplished so that the personnel can be released, the organization which now has operational control of such a unit will report this fact to G-3, AFHQ, for disposition of the Italian personnel. German personnel will not be used to release Italian civilian personnel. Also it is considered impracticable to work the Germans along-side Italian civilians.

SUMMARY

- d. The surrendered personnel may be used on any type of work including clearing of mines, after the proper training and the provision of equipment. For the present, German personnel classified as PWs can only be used on work as provided by the Geneva Convention. Within these limitations General MCGRUDE pointed out that maximum use of the German personnel could be used for units to be redeployed. He cautioned about the use of German personnel in maintenance units at the moment, inasmuch as the maintenance program is critical and it is desired that nothing be done which would retard the progress of the present program.
- e. It was announced that the technical service regiments would remain at present under the command of PBS and Fifth Army for the control of the Italian PW and military units which remain, and, for the German units, which are formed.
- f. Under this program no change is contemplated in the present instructions for the disposition of enemy captured materials.

SUBJECT: Classes of Germans and Italians Who Should be Detained in the Event of Surrender of German Armed Forces

1. It is recommended that the following classes of Germans and Italians should be detained for security reasons in the event of surrender of the German Armed Forces in Italy:

a. Germans

(1) All SS Police Units. These include some 10 SS Police Regiments, estimated strength 12 - 15,000, all Kasernierte Polizei units, estimated strength 1000. The Divisional or Army Military Police units should not come in this category, as they will be needed to assist in maintaining order. All German officers and NCO's of 1 Italian Waffen SS Division and the German cadre personnel of 24 SS Mountain Division at present in North East Italy should be put into Camps. Estimated total, 1,000 to 1,500.

(2) Any troops of the Brandenburg Regiment (sabotage troops and trained in subversive activities) and Spreng Kommandos (demolition troops). Estimated total, 1,000.

(3) All members of German secret intelligence and secret police organizations; viz, ABWEHR, Sicherheitsdienst, GESTAPO, (including Grenz Polizei) and Geheime Feld Polizei, and any other office, branch, or department of the Reichssicherheitshauptamt not already specified, and any special units or organizations under its command, many Intelligence personnel at Division Headquarters level and above will probably have to be detained at a later stage. Approximately 600.

(4) All NSFO's (Nazi Commissars). Estimated 100.

(5) Members of Propaganda Companies including the Propaganda Staff HOTZ and 699 Pz Propaganda Company. Approximately 400.

(6) A certain number of senior officers and General Staff Officers known to be ardent Nazis. The placing of these in detention could probably wait until disarmament has been completed. Approximately 250.

(7) All Germans who are known to be War Criminals or who may be classed as such after the surrender. Estimated 100.

(8) Marine Einsatz Kommando 80 and Meeres-Kampfer Group of the K.d.K (Kommando der Verbände) (estimated total 100).

(9) Certain personnel, as indicated, of the following organizations should be taken into custody provided that they can be spared or as soon as they can be replaced:

NSKK (Nazi Kraftfahrkorps): Officers of the rank of Staffelführer and above.

TENO (Technische Nothilfe): Officers of the rank of Landesführer and above.

R/D (Reichsarbeitsdienst): Officers of the rank of Arbeitsführer and above.

TODT Organization: All German personnel. (03)

(Estimated total, 1000).

The above does not include parachute troops of which it is estimated there are 40,000, or German officers and NCO's from Armed Forces between the ages of 18 and 25, the latter amounting to approximately 60-70,000 of which 10,000 are officers. Both of these classes of Germans form a possible source, in the first place, for potential guerillas for activities in the establishment of a National Redoubt and in the latter class, they form the most likely source of any underground revival of National Socialism. Since there is no positive evidence that the groups as a whole intend to operate along the lines indicated, it is suggested that in view of the numbers involved, that these two classes be treated at least initially as the ordinary German formation unless evidence comes to light which indicates their intention to continue or revive resistance. In this case they must be detained pending disposition. In any case we must be prepared to take the necessary action to implement this.

b. Italians. A large number of Italians, especially those most incriminated in the eyes of their compatriots, will either attempt to fade into obscurity or else be liquidated by local partisans. Any Italians of the following classes who surrender should be detained for security reasons:

(1) All Italian SS Officers, NCO's and troops, in particular members of 1 Italian Waffen SS Division. Approximately 20,000.

(2) Members of Black Brigades and local anti-partisan units, including T.G.L.I./ENTO Regiment.

(3) Members of "M" Battalions, especially members of the affiliated ARDITI Battalions which are found in most of the large cities.

(4) Troops of the "Republican" FOLCORE Regiment (FOLCORE Battalion and NEMBO Battalion), and of the VEGA Battalion, the NP Battalion and GAMMA Group of 10 FLOTMS. Approximately 4,000.

(5) All personnel of Fascist Training Schools and Anti-Partisan Schools. Approximately 3,000.

(6) Token senior officers of Italian Republican Divisions.

Total number of Italians, up to 90,000. However, it is considered that a large proportion will be liquidated or go into hiding.

c. Neither German GAF or Naval personnel have been considered.

2. Estimated total of personnel to be detained initially:

a. Germans 15,000 - 18,000

b. Italians up to 90,000

105,000 - 108,000

c. Total does not include parachute troops or 18 to 25 year age group included in paragraph above.

3. Although initially none of the above classes will be classified as prisoners of war, it is recommended that normal prisoner of war channels be used for evacuation, administration, interrogation, etc. This would greatly aid in arriving at final disposition of the above classes of Germans and Italians, and of selecting those who may be declared as prisoners of war by Supreme Allied Commander.

4. The above recommendations should not be included in the instructions issued by Commanding General, 15th Army Group, to Commander-in-Chief, South West, but should be issued as a part of secret instructions to the Armies implementing.

5. Copies of this letter have been sent to Fifth and Eighth Armies in order to facilitate their planning.

1. Although it is agreed that the categories of German and Italian surrendered personnel mentioned in paragraph 1a and b, of the basic communication, with the exception of parachute troops, may need to be segregated and placed in confinement, it is not possible to pass all disarmed surrendered troops through normal prisoner of war channels as appears to be indicated in paragraph 3 of your letter for the following reasons:

- a. the cage space in ITALY is totally inadequate to deal with the numbers
  - b. the large amount of movement involved in sending them back to base cages (LEGHORN for United States captures and TIRINTO for British captures), and then returning them to the North of ITALY after screening, is unjustified and undesirable;
  - c. the difficulties created by having in the same cage, prisoners of war on one scale of rations and system of documentation, and disarmed troops on a different scale, would lead to endless confusion and dissension.
2. Consequently, on receipt by you of the order of battle of the enemy surrendered forces, troops of the categories mentioned in paragraph 1a and b of your letter, may be segregated in your discretion as far as your resources allow, having regard to the policy that surrendered enemy forces should be left with sufficient key personnel to enable them to be self-administering. Notice should then be given of the desire to evacuate to PW cages as outlined in paragraph 16c of FHQ letter, file AG 323/061 GDS-0, dated 3 April 1945, subject: "Occupation of North East Italy", relating to recalcitrant enemy personnel.
3. From information received from the German emissaries, it is likely that the numbers who require segregation will be somewhat in excess of the estimate in paragraph 2a of your letter. The estimate given by the German emissaries for Germ SS and Police is 57,454. On the other hand, your estimate of Italian troops that require segregation appears to be in excess of the actual numbers, as the German emissaries gave a total figure of 90,000 for all Italian troops, and it is considered that not more than 20 per cent of these will be classified as recalcitrant.
4. Personnel not in the categories mentioned but who are considered dangerous to security should be treated in the same way as indicated in paragraph 2, above.
5. Detailed instructions on the treatment of surrendered personnel are in the course of preparation and will be issued shortly.
