1. During recent visits to out-stations in North Italy, I have noticed a certain lack of uniformity in the carrying out of Liaison duties.

The general situation in each Province is frequently quite different to the next, and each Territorial Commander has his own local problems on which the MIL LO should advise him. There are nevertheless many questions, such as Captures Enemy Material, accommodation, etc. which are similar in all areas, and these should be handled in a like manner by all LO's.

An out-station LO, being a "one-man band", has necessarily to work on his own to a great extent, his policy guided by letters from HQ and by the brief and unavoidably infrequent visits from myself. He therefore tends to become parochial.

2. In order to achieve uniformity of policy, I recommend that all LO's should from time to time not only visit HQS and MILHQ, but also their next-door neighbours, who in most cases are only a few hours journey away, and with whom they could profitably compare notes.

3. Senior LO's Italy will be informed of all proposed visits, which should be undertaken at times when "business is slow" and when LO's can get away from their bases.

1. This report covers the period of 20 August to 26 August inclusive.
2. I arrived in Naples from Rome at 1830 hours 20 August and the next five days were spent in studying the reports of losses incurred in shipments from Naples to Sardinia, and in familiarizing myself with the procedure in effect at the MMIA Warehouses, team tracks and loading docks.
3. Through an examination of the records I learned that notwithstanding the fact that in some instances the figures are large, that the losses when analyzed show a relatively small percentage of the merchandise shipped. In many instances the losses are actually less than 1 percent.
4. I also noticed that the greatest losses have been from shipments of flour, rice, and sugar. It will be noted that all of these articles run and spill easily. I noticed that many of the sacks were in poor condition. It is therefore, my opinion that the greater part of these shortages are due to spillage rather than pilferage. Although there is no question that there are a few cases of pilferage because in a very few instances foreign matter was found in some of the sacks when they arrived in Sardinia.
