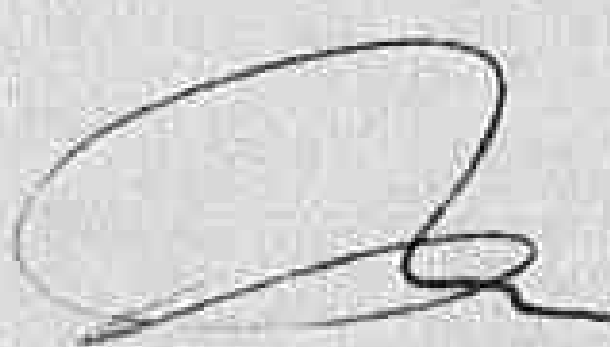

- 2°- Lieut. CARASSAI and Lieut. PEDRETTI inform us that the other 12 prisoners asked to be repatriated with letter No. 7308/2208/Coll, dated 14 March 1945, belonging to Camp P.O.W. n. 305, have nothing to do with the filo-fascist POW who are the majority in said Camp.
- 3°- We inform you that in Camp 305 are three tents reserved to elements of sure anti-fascist faith, tents n. 6-30 and 27.
- 4°- For this reason we have renewed our request with letter N° 19499 dated 2 July 1945, to repatriation for Lieut. SANDRI Alberto, Lieut. FERRI Federico, Lieut. BELLEI Enzo, sub Lieut. D'ANDREA Febo. We reserve ourselves to ask the repatriation of Lieut. LUSARDI Domenico, as soon as we get the information needed.
- 5°- We beg your S.C. in consideration of the said information to call this matter to the attention of the Competent Authorities and request the repatriation of said officers and the other soldiers whose name appeared in letter n. 7338, dated 14 March 1945.
