The above mentioned two airmen are not prisoners. We are unable to state if the Molinaro referred to in your letter is one of the two servicemen mentioned above or a third person.

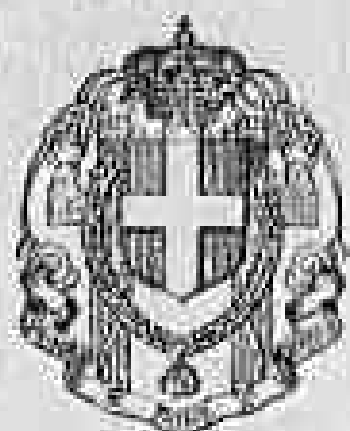
