The fact that some 600 repatriated POW have had to be found hospital accommodation in the command has been represented to the I.P.O.W. Division A.C., who have promised to make every effort to evacuate these cases to MERANO.

The shortage of medical stores spoken of has been investigated. Supplies were despatched from LAGLIANA to BULOGNA on 27.12.45 (Does not include dressings other than adhesive plaster) and the War Ministry at the moment are looking into the question of meeting present requirements.



I add that the need of this medicine is such that the sick people in question are obliged to buy it at exorbitant prices.

In spite of the inquiries in the correspondence of the office, we could not see if it is true that in the Camp of Chieti, a PW was charged 560 lire for some tablets of Vitamin B; it was even impossible to see if the money has been given back to the PW.

Still we let you know that, following our regulation, Vitamin B is one of the medical specialities and when it is needed it is necessary to have an authorization for buying it outside, being a product not to be found normally in the military dispensaries.

It is presumed that for the above mentioned case the PW didn't have the medical prescription, and the authorization to buy Vitamin B outside, and that the medicine would be debited to the PW as a medical speciality.

Dear Grafftey-Smith,

Gardner has suggested that I should seek your assistance on a question of treatment of our prisoners by the Italians, which cropped up in connection with the adjustment of prisoners' accounts for the advances they received whilst in captivity. I hope that you may be able to get the necessary information without difficulty; we do not want to press you to make any very extensive enquiries.

The position is that several officers have reported that the Italian Authorities made charges against them for the cost of drugs required for their treatment in hospital. One particular case occurred at the infirmary at Camp No. 21 (Chieti) in the Spring of 1943, when a Lieutenant Carris claims to have been charged 560 Lire for Vitamin B tablets. We know from the Protecting Power's telegraphic report of a visit on the 7th January that prisoners in the infirmary at that time had to pay for special drugs and bandages, but we heard later in a report from the International Red Cross Committee that this practice had ceased. At the time, the camp commander was Colonel Guisepe Massi.

I should be very grateful if you could let us know (i) whether the Italians ever ordered such charges to be made generally, and (ii) whether the charges made at Chieti were ever refunded. If you have difficulty in ascertaining what did happen, please do not bother to pursue your enquiries, but we should be glad of any information on the point, which can readily be provided.
