Death Battalion and Sergeant Baldassarri of Zama battaglion are identified respectively as follows: Mario Izzo, son of the late Antonio and Zana Carmela, born at Calvi Risorta (Naples) on the 13/6/1909, and Baldassarri Omero, son of Giuseppe Emilia Crespi born at Rassina on the 9th of November 1922: we have received information from the competent authorities that both were killed.

Izzo on the 15 May 1945 in the district of Sograte (Milano) and Baldassarri on the 9th of November 1944 in the line at Forli.

Anyhow researches are still being made and I will forward to your S/C any details which Y shall receive as soon as possible.

SUBJECT - FRE - CENSORSHIP

PW No. 50308 Carab. LUSUARDI Adorus.

The following extract from a diary of the above PW is reported for information.

"The place where I was, was the last police out-post on the Anglo-Egyptian Sudanese frontier. It was a nice village with a healthy climate, where things were quite well and calm.

On the 15th December 1938, we took up our position at the defence post, at the entrance to the village which is at a distance of over one kilometre from the barracks, because, in Africa, all the more or less important villages always extend to more than a kilometre in length. The night it was my turn to guard the defence post when at about midnight I was attacked by a discharge of rifle fire on the part of the rebels from which I miraculously escaped death. Two days later, I was attached to a reconnaissance battalion and a few days afterwards I got the opportunity of venting my hatred for the blacks, because we immediately began hanging and shooting them 'en masse', burning entire villages, about which I could write a novel.

On Christmas Eve, finding ourselves in the heart of a wood, at dawn we were attacked by rebels and in the skirmish, a bullet pierced the water-bottle full of water which I was carrying slung across my shoulder. At dawn of the next day during another attack made by these rebels, my helmet was pierced by a lance hurled by them, and, even this time, I was unhurt. After two hours of fierce shooting, we succeeded in taking about 20 rebels prisoners while 73 others were killed. I was given charge of the said prisoners and ordered to take them immediately to Dembidolls - the prisoners were not bound - with orders to shoot if they attempted to escape. On my arrival at the village, about 13 hours of the Holy Christmas Day, there were only 7 prisoners because I had shot the others in order to have less trouble from them.

After a brief interrogation the 7 prisoners were given to me to be shot, but seeing that 7 bullets were of greater value, I killed them with my own hands, with a solid pick-axe.



1. Reference is to your IPW/54/1 of 22 April 45 inclosing correspondence from the Italian Minister of Foreign Affairs requesting that the Allied Governments give a new warning to the German Authorities, against the mal-treatment of Italian Nationals held by the Germans.

2. The matter was referred to the British Resident Minister who called attention to the fact that a warning had just been issued to Germany on behalf of all Allied Nations at war with Germany from London, Washington, and Moscow, which, although not technically applicable to Italians, would, it was thought, afford them some protection. The matter was at the same time referred to the U.S. Political Adviser who expressed the view that the request should receive urgent sympathetic consideration.

3. In the meantime, the surrender in Italy and West Austria has taken place. For your information, it is understood that the German Command has undertaken to afford proper treatment to all P/W and civilian internees while held under its control. In the circumstances indicated it is not believed that further action at this time is practicable.

As these men do not enjoy juridical protection and are therefore exposed to any arbitrary action by the Nazi Authorities to an even greater extent than the other prisoners of War, the Ministry for Foreign Affairs believe that a warning to the German people against possible acts of violence and revenge might render their situation less precarious and would be amply warranted on humanitarian grounds.
3. In the above consideration, the Ministry for Foreign Affairs beg the Allied Commission to interest the competent Authorities in issuing through the most appropriate channels a warning to the German Authorities to consider the Italian military internees in Germany in the same way as the P.O.W. of other nationalities, with all the guarantees accorded the latter by International Conventions.
The Ministry for Foreign Affairs will be very grateful for those steps that the Allied Commission will see fit to take in the matter.

Dear Admiral Stone,

in the last few days, some newspapers of the Capital published the news that Hitler ordered all interned foreigners to be shot before the Allied liberating armies reached their concentration camps.

This Ministry had informations which confirmed that the Italian officials who refused to co-operate with the Germans, and the interned Jews had been killed in mass by the retreating German troops.

These news greatly alarmed the Italian families which have relatives in Germany.

I want to give you these news at once so that you will kindly see whether it is possible to ask the Allied Governments to give a new and public warning to the German authorities, through whatever channel they will deem most advisable, against committing again such crimes, and threatening reprisal from the Allies and the punishment of those who are responsible.

On its side, the Ministry of Foreign Affairs has already asked for the intervention of the Central Committee of the International Red Cross in Geneva, asking it to do what it can to prevent such atrocities from happening again.

With many thanks, I beg you, my dear Admiral, to let me know the result of your intervention with the Allied Government.
