Reference is G-5: 383.6 of 14 and 19 April.

1. The British Foreign Office have reminded this Headquarters that the proposed employment is contrary to articles 31 and 32 of the Geneva Convention unless the Italian co-operators are prepared to waive their rights under these articles.

2. They say furthermore, that it would not be right for non cooperator prisoners of war to be employed on this work even though they volunteered for it.

3. We would be pleased to hear when a decision is to be expected from the Italian Government.

The Italian Government considers it necessary to adhere to the clearing up of all the fields that are mined in Italy; it is thought that the utilization of the Italian Military Co-operators for this work should be given under the following conditions,

- the units should be voluntary and should only be employed on Italian soil.
- They should be paid as the personnel of the R. Army are paid for the same work, that gives them extra pay for every mine recuperated or destroyed, even if this latter is to be paid by our Government.
- They should have the status of the other Italian Military co-operators. "

We await your answer regarding the system to be adopted.
