REGULATION FOR RATIONS WITHDRAWAL

This follows telegram No. 11249/S/1 of the 18 Oct. 44.

It appears that some units when indenting for rations with vouchers Mod. K instead of showing ration strength as per establishment fixed by the Allied authorities have been showing ration strength as it appeared in list attached to letter 7650/S of the 26/7/44.

Apert from the facts that the ration scale must only be effective in the unit itself, the withdrawal of ration on such bases, causes evident errors in the distribution of Rations of Rice and Maccaroni from the food depots, lack of balance in the issue of ration is caused by the transfer of a unit for a determined period and which would mean an issue in excess or below the laid down scale applicable to the A/M foods.

So as to avoid further errors the order that units (no exemption to the rule) give to the depots concerned the voucher compiled as from the scale of ration shown below.

For the Royal Navy and Air Force this rule only apply to unit who owing to their locality are obliged to the disposition taken on letter 7700/S of the 29/9/44 remains valid about the fourthnight assignment to be withdrawn from the depot of the Italian Army which must take place with withdrawal voucher M.K. in triplicate (that for the 2A/m foras).

In that we precise that voucher M.K. will only be used for fundamental rations the rest of rations will be shown on older type of request vouchers.

As regards to the additional ration the third copy is not needed as not requested by MMIA.

The addresses must communicate the rules and regulation contained in this letter and send copy to dependant corp and units.

Withdrawal of Rations from Rome Depot

To comply with verbal request we attach list of the units which are authorized to draw rations from the Rome Depot showing the maximum strength of each unit.

Copy of this list is also being sent to the Rome Depot so as to enable them to comply with the daily list ; eventual changes will be communicated so as to enable alterations.

For the districts of Viterbo Littoria, and Frosinone and for Cerseti the strength shown refers only to actual personnel on strength. Rations for the personnel recalled in the army will be requested separately, in accordance to orders.

For the CCRR the data have been slightly altered on indication from their Commandant; Who has pointed out that on the 15 Sept they have opened a school for CCRR in Rome which does not figure in any previous list. Therefore, the strength does not exceed the prescribed limits.

Authorization given to some unit to draw indefinite No. of rations or for limited periods, ~~unlimited~~ are indicated on the list and without serial No.

Subject: Italian Rations.

Referring to letter 4601/S dated May 9, 44 and to the attached instructions of this Ministry regarding issue of rations (letter ref: 4430/S dated May 5, 44) sent to you for information.

The units are drawing rations from the depots with a fortnightly indent form i.e., for the period authorized by MMIA (according to previous instructions (see letter ref 4430/S dated May 5) rations were drawn every ten days. Strength of the unit is shown on return as for the first day of fortnight, and necessary changes of strength will appear on the returns of the following fortnight. The fact reported by MMIA can be explained as follows:

- 1) Units owing to lack of transport, can be compelled to draw rations for some days in a quantity inferior to the ration strength, eventually making up in the following days.
- 2) Food supplies depots, owing to temporary lack of supplies because of the shortage of transport, must sometimes issue a number of rations inferior to the ration strength, making up the difference later on; when difficult food supplies are available.
- 3) Movements of Units cause changes of strength which consequently tell upon the issue of rations.

Anyhow, rations are always as they must be, drawn on the basis of effective ration strength.
