SUBJECT: Release of Requisitioned Real Estate

TO : Unit Commanders, all units assigned and attached this command.

1. The following regulations with respect to the release of requisitioned Real Estate is published for the information and guidance of all concerned:

a. Notice of the expected date of termination of occupancy of requisitioned property will be given to the Real Estate Section, this headquarters, as far in advance as possible.

b. Upon termination of occupancy unit will be responsible for the return of keys to the Real Estate Section unless authorized caretakers are to remain on the premises after unit has vacated, in which case instructions as to the disposition of keys will be obtained from the Real Estate Section.

c. Final inventory forms may be obtained from the Real Estate Section. These will be prepared and signed by the unit commander and the owner, lessee or local representative. In the event that the owner or his representative is not available, the responsible officer will execute certificate to that effect. This certificate, together with two copies of final inventory, will be forwarded to the Real Estate Section.
