SUBJECT: Escaped PW/SEP.

The attached letter G-5 333.7-67 dated 6 March 47 is addressed to you and not to IMAS.

In November 1946 MMIA were asked to ascertain with what Italian Authority details of the transfer of these prisoners should be arranged.

It will be seen from the attached correspondence that the authority in question is the Minister of the Interior.

Since the matter is one which does not concern the Italian Army but is the concern of the Minister of Interior with whom IMAS normally have no dealings, will you please accept action on the matter.

Reference is made to this Headquarters letters G-5: 965.13 dated 8 November 1946 and G-5: 965.23 dated 13 December 1946 and also to Land Forces Sub Commission (MMIA) 243 A dated 9 December 1946. FOLIO 10. FILE #243 A.

1. A further request has been received from the International Red Cross, dated 25 February 1947, for the transfer of German and Ukrainian PW, escaped from British custody, from Italian camps to 1 SEP Centre.

2. It is therefore apparent that no move has been made by the Italian Ministry of the Interior to return these escaped PW. It is possible that the German PW were included in the recent repatriation from FOSSOLI Camp. The Ukrainians, however, are now stated to be held in LIPARI Camp.

3. The original roll submitted by the International Red Cross on 28 September 1946 contained the names of 6 Ukrainian escapees. Rolls now submitted contain 17 escapees from RIMINI and 35 Ukrainians who are not specifically shown as escapees from Allied custody. Nominal rolls are attached hereto.

4. In view of the length of time which has elapsed since this matter was first raised, will you please again approach the Italian authorities and endeavour to obtain their agreement to the return of all these escapees to RIMINI.

5. It is requested that you inform GHQ CMF when agreement is obtained and the number of persons involved, confirming to this Headquarters whether German PW are still at FOSSOLI and what proportion of the 54 Ukrainians are ex-Allied custody.
