1. Enquiries have been made concerning the future of those Italians listed by you.
2. It is understood that those convicted of criminal offences such as stealing Allied property, selling of false currency etc, have had their cases turned over to the Italian Ministry of Grace and Justice for review.
3. The cases of those charged with "espionage" or "sabotage" are still under consideration by the Allied legal authorities and the future of such persons has not yet been decided.


