Forwarded herewith is a copy of a report by Capitano Salemi, an officer of the Legnano Combat Group, on the treatment he has received from the partisan leader, Signor COZZI, at NOVI LIGURE.

During the campaign Capt Salemi commanded an Engineer Coy firstly in the C.I.L. (Italian Corps of Liberation) and afterwards in the Legnano Combat Group, taking part in the recent advance.

Not unnaturally, he resents the appropriation of his Villa by the local partisans, and has been placed in a very difficult position by their high-handed refusal to return it to him.

As incidents of this nature have a very profound effect on the morale of the Officers and men of the Combat Group, and may lead to dangerous discontent, it will be greatly appreciated if you can assist him in the matter.
