1. On 9 Aug 46 application was made to ORD your HQ for the issue of 44 bulbs and 44 torch batteries to the "TOLMEZZO" Alpini Bn. The application was turned down on the grounds that issues could not be made to Italian Units.
2. The TOLMEZZO Bn is under operational Command of your HQ and is employed on the Security Line and on guarding Civil Prisons in 13 Corps Area.
3. In view of the fact that the torches were originally obtained from British sources (details not known), that no torches exist in Italian ORD Depots, and that a torch is considered necessary when carrying out the duties outlined above; it is requested that Staff Authority is given for the release of the items mentioned in para 1 above.

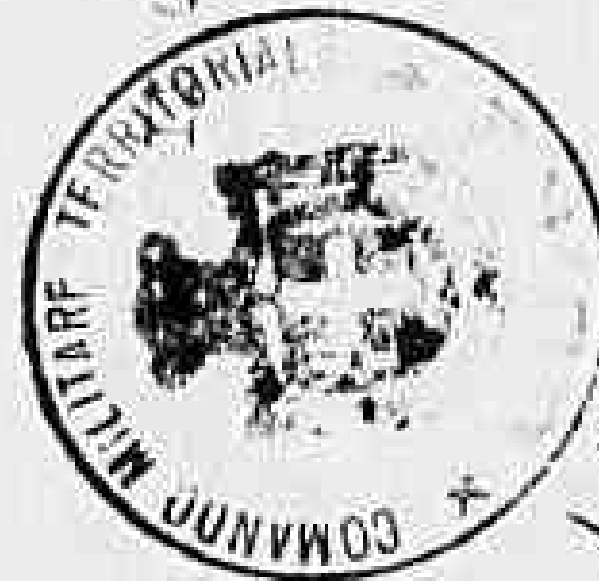
