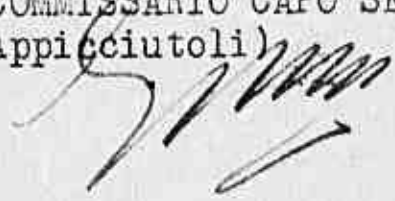

1. 13 CRASC (Supply Units) ANCONA has 250,000 liters wine in stock in its Base Supply Depot to be handed back to Italian Depots.
2. Due to large stocks already held in ANCONA and FORLI Food Distribution Depots rail movement has been arranged during period 3 - 9 September, as indicated below:

3. The wine in question is property of the War Ministry; therefore, no accounting action required, except interdepot transfer (British BSD to No. 76 Food Distr. Depot ANCONA). No. 76 Food Dist Depot ANCONA will take quantities of wine on charge and despatch same to destinations listed in para 2 above.
4. Instruct O.C. No. 76 Food Dist. Depot ANCONA to liaise with 13 GRASC concerning handover of the above.
