1. It is planned to turn over the 18 Displaced Persons Centre from Allied Forces Headquarters Control to the Provincial Committee of Assistance of the Post Bellica on 1 May 1947.

2. At this critical period of the transfer of the Camp, it is necessary to disturb the administration as little as possible. The Officers and soldiers from your Command now actively in charge of the Camp have performed a most commendable task and are considered highly competent.

3. I am therefore anxious that the present Italian Army Staff consisting of:- 2nd Lieutenant Manon Nâno and 2nd Lieutenant Moore Lorenzo with the present strength of twenty soldiers⁵¹²³ be retained in the administration of the 18th Displaced Persons Centre.

4. I should be very glad of the Commander's assurance that this staff may continue to administer the Camp from the

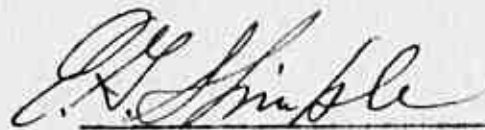
1. The maintenance of the Camp mentioned in the basic communication is absolutely necessary. It is a link in the chain of camps, established by the Italian Government under the supervision of Allied Forces Headquarters, for the repatriation of Italian refugees. At the present time this camp handles over 200 persons per week from the areas of Pola, Fiume and Zone A. A few returned Prisoners of War still pass through.

2. Two Italian Army officers and a number of Italian soldiers now operate the camp efficiently and without favouritism. At this time, with refugees on the increase, it is highly undesirable to change the administration staff.

3. Post Bellica is the responsible Italian organisation which controls the entire Italian refugee system. A.M.G., Udine is interested in as much as this camp is our means of removing refugees from Udine Province.
