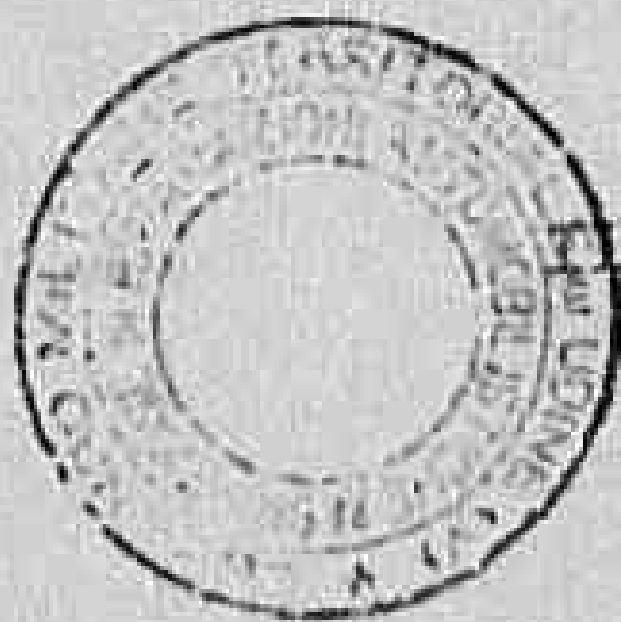

reference your letter dated the 1st of May 47, I regret the delay in replying, but as it was forwarded to my old address in London, it has taken quite some time before reaching me. Regarding the question of the car, I don't know what AMG Gorizia are talking about, except for this: whilst I was a CAO, at Corsons in July 45, I held on to a 1500 Pint of doubtful origin, but as far as I can remember, did not even have any number plates, it had obviously been a German Army car and at that time was claimed by a local brick merchant, who when asked for details about the origin of this car was most ~~elusive~~ and vague. The whole matter was however taken right out of my hands when I was transferred to Pola on the 1st of July 45; the car in question of it is the same one was left in the yard of HQ. AMG Gorizia area in charge of the assistant legal officer, a Lt. L. Becker, AUS; this statement can be corroborated by a Captain L. Miller, AUS who was also there at the time. It is most definite that I did not take the car with me to Pola as I was using other means of transport, well I hope this explanation will satisfy AMG Gorizia.

The remainder of the letter is of a personal nature.
