1. With reference to your letter of 25 January 1945, and letter undated February 1945, the Naval Allied Commander-in-Chief, Mediterranean, on 19 February 1945, appointed Commodore Guy L. Warren, Royal Navy, Chief, Navy Sub-Commission, AC with the rank of Rear Admiral.

My dear Mr. Prime Minister:

I have to inform you that Rear Admiral Guy L. Warren, Royal Navy, has been appointed Chief, Navy Sub-Commission, AC, Vice Rear Admiral C.E. Morgan, Royal Navy, effective 19 February 1945. Commodore H.W. Zirrell, U.S. Navy, will continue in his present capacity as Deputy Chief, Navy Sub-Commission, AC. COLLISION IN BRINDISI HARBOUR.

With reference to the collision between the Italian Motor Ferry Boat 'SANTA MARIA' and the Italian Naval Patrol Boat A.S. 116, which took place in Brindisi Harbour on Sunday, 22nd October, 1944, the following are the recommendations of the Board of Enquiry held to investigate the matter :-

"It is recommended that representations be made to the Civilian Authorities to :-

- (a) Enforce stricter control of the load limits of these ferryboats.
- (b) Insist that on all ferryboats of similar pattern to the 'SANTA MARIA', seats are fitted to accommodate all passengers permitted, and it be strictly prohibited for passengers to remain standing when the vessel is underway, so obstructing the view of the helmsman."

It is requested that you will inform the Prefect of Brindisi that :-

(1) all Italian ferryboats are to be provided

"It is recommended that representations be made to the Civilian Authorities to :-

(a) Enforce stricter control of the load limits of these ferryboats.

(b) Insist that on all ferryboats of similar pattern to the 'EMMA MARIA', seats are fitted to accommodate all passengers permitted, and it be strictly prohibited or passengers to remain standing when the vessel is underway, so obstructing the view of the helmsman."

It is requested that you will inform the Prefect of Brindisi that :-

(1) all Italian ferryboats are to be provided with navigation lights (i.e. port and starboard lights)

(2) That seating accommodation should be provided for all passengers so that the view of the coxswain is not obstructed.

(3) If (2) is not possible, standing in the bows of these ferry boats should be forbidden if the coxswain's view is obstructed, and that the owner of the ferryboat be warned that his license 'to ply for hire' will be withdrawn if this rule is disregarded.

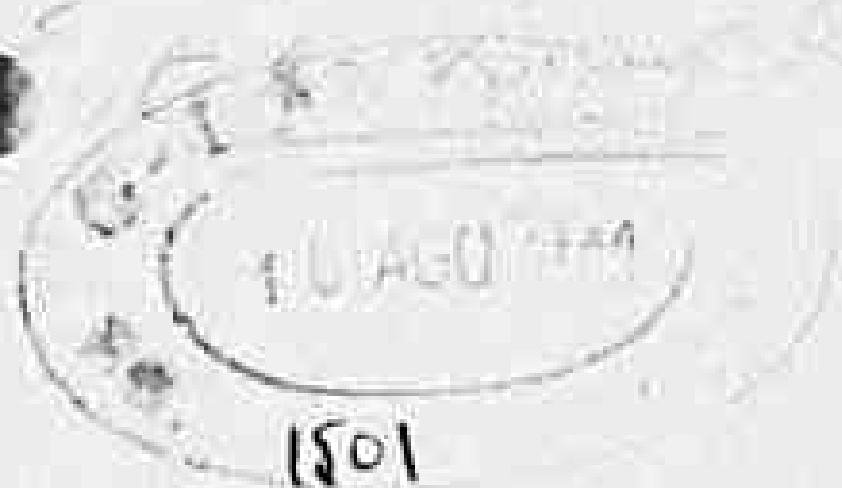

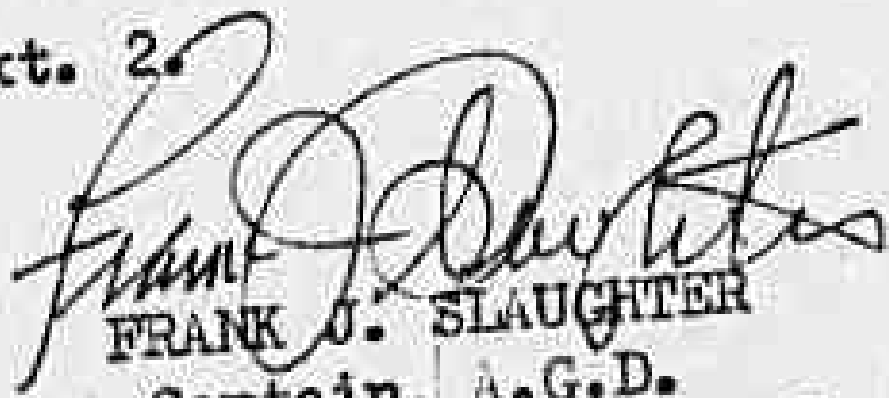

1. Inasmuch as there is no U.S. Naval Officer permanently stationed in Civitavecchia as Senior Officer present, it will be appreciated if through the facilities of your office Commanding Officers of U.S. Naval Vessels of all classes arriving in Civitavecchia or the Commanding Officers of any U.S. Naval Units located at that place be notified that the uniform for U.S. Naval Officers visiting or reporting in Rome for duty is either gray, khaki or whites. Wearing of blouses with gray or khaki is optional but black ties must be worn at all times. For enlisted men the uniform is undress whites with black neckerchief.

2. Dungarees are forbidden except in the case of drivers or crews of vehicles such as trucks, weapon carriers, etc., when the duty to be performed may be of such a nature as to require the wearing of dungarees. Such drivers and crews are not to circulate on foot about the streets of Rome while so dressed.

3. The Military Police have been instructed to apprehend any U.S. Naval Personnel appearing on the streets of Rome in any uniform other than those given above.

4. It is desirable that any U.S. Naval Personnel visiting Rome for leave purposes also be informed that there are no billets available and food is very difficult to obtain. Leave parties preferably should arrive in the morning and leave sometime before dark of the same day.

1. Inasmuch as there is no U.S. Naval Officer permanently stationed in Civitavecchia as Senior Officer present, it will be appreciated if through the facilities of your office Commanding Officers of U.S. Naval Vessels of all classes arriving in Civitavecchia or the Commanding Officers of any U.S. Naval Units located at that place be notified that the uniform for U.S. Naval Officers visiting or reporting in Rome for duty is either gray, khaki or whites. Wearing of Blouson with gray or khaki is optional but black ties must be worn at all times. For enlisted men the uniform is undress whites with black neckerchief.
2. Dungarees are forbidden except in the case of drivers or crews of vehicles such as trucks, weapon carriers, etc., when the duty to be performed may be of such a nature as to require the wearing of dungarees. Such drivers and crews are not to circulate on foot about the streets of Rome while so dressed.

5. The Senior U.S. Naval Officer, Rome, regrets exceedingly the necessity of imposing on you at this time for assistance in the above matter but assures you of his sincere appreciation for any cooperation you may conveniently extend.

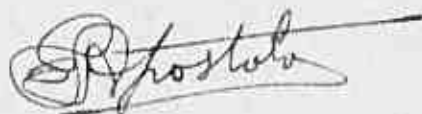

Reference your cable No. 203 dated 21 April 1944 received today together with File No. 1201 dated 21 April from the Ministry of War - General Directory of Military Health.

We wish to inform you that the British Seaman James Edward Botth Serial No C/IS 3446 died here on 30 October 1942 at 2200 hours, death resulting from "enterocolitis caused by dysphtheria bacillus" and that he was buried in the Cemetery of Grottaglie special camp for foreign military.

At the time of his reception in this Department he was wearing an Italian uniform; he stated he belonged to a group of survivors who had been saved by an Italian Hospital Ship.
