Information has been received that the above-named is in Prisoner of War Camp No. 209 and the Commandant has been requested to hand him over to Italian Police Authorities.

2. He has stated that he was serving in "SCIPIONE AFRICANO" and deserted on 30th January 1945 in Naples and went to his relatives in Florence. He was arrested by Carabinieri and on 10th March, 1945, handed over to British Police who sent him to Arezzo Prisoner of War Camp on 15th March, 1945, and on the 1st April 1945 he was transferred to 209 Prisoner of War Camp.



2. PIRONDINI was admitted to 209 PW Camp as a PW and, according to a statement made by him, he has never been a cooperator although he did, after the Italian Armistice, cooperate with the Allies.
3. G2 (CI) WHQ state that PIRONDINI is of no security interest and, in view of the fact that he appears to have been a sort of unregistered "cooperator" it is considered that he should be transferred to the Italian Military Authorities and that they should take necessary disciplinary action with regard to his absence.
4. Will you please inform MMIA as above and request that disposal instructions be forwarded to Commandant, 209 PW Camp.

Sir

I have to report that at Bari on Sunday 6th January 1946 about 2100 hours I was on duty as visiting N.C.O. dock duties accompanied by I/Bdr. Stewart J Garrison Police who was on general patrol.

While patrolling the dock area I had occasion to search a wooden building in the Castle - Sidings though which I suspected flour was being pilfered, on entering the premises I found an Italian Marine by the name of Loiacono Antonio of M/S 73 Regia Marina who endeavoured to conceal himself in a corner of the hut.

When questioned he said he was waiting for a friend to bring him some coffee he had no pass; on the floor of the hut I found traces of flour which lead from the window to the door. I conducted him to No 4 gate where I handed him over to a member of the Guardia di Finanza who escorted him to be detained in the Ports Detachment guard room.

Sir

I have to report that at Bari on Sunday 6th January 1946 about 2100 hrs, I was on duty as visiting N.C.O. dock duties accompanied by L/Bdr. Stewart. J Garrison Police who was on general patrol. While patrolling the Castle - Sidings I saw a rowing boat approach when challenged to stop one man immediately jumped overboard, and I soon lost sight of him in the darkness. The other an Italian Marine by the name of Jacobacci Azeglio brought the boat to the quayside, which after examination was found to contain (22) twenty two, (3) three gallon drums and (4) four, (5) five gallon drums of green paint. I conducted him to No 4 gate where I handed him over to a member of the Guardia di Finanza who escorted him to be detained in the Ports Detachment guard room. I returned with the motor launch and towed the rowing boat and contents to the Canaletto, where I placed it under the supervision of a member of the Guardia di Finanza.



I have to report that to-day, at about 4.30 p.m., Sotto Ufficiale Domenico D'ANTONIO of the Italian S.S. TURIDDU, on being brought to Marsa police Station by P.O. 557 CRECH and searched, was found to be in possession of 21 pounds in Bank of England currency notes, which he had imported into Malta without a permit in writing from the Governor or a person on his behalf, and had hidden on his person one hundred packets of ten cigarettes (Players) each, which he was attempting to export out of these Islands without a permit from the F.C.C.O. The Captain of the ship, on being contacted, declared that D'ANTONIO had been previously warned by him regarding the provisions of the Finance and Exportation Regulations.

2. As the ship is leaving early to-morrow morning, D'ANTONIO was charged accordingly in Court to-day and, having been found guilty, was fined 68 pounds, the Court ordering also the confiscation of the money and of the goods which had been seized and exhibited in Court. As D'ANTONIO was unable to pay the fine imposed by the Court, he is undergoing imprisonment in substitution therefor.

Last Sunday some rallies were held in the Campagna Community (Salerno) for the administrative elections. Among other addresses there was one made by the Navy Non-Com Michele Villani, son of Rocco, a typist, who was here on leave to undergo examinations.

He, after having stressed the speeches previously delivered by other Communistic orators, cruelly inveighed in a fashion unworthy of a soldier, against the Allied fleet, particularly against the British Navy, shouting that we had to get rid of England once for all as she has always kept us in slavery, and to open our arms to Russia who is the only power who will be able to alleviate our sufferings.

The honor of the British Navy was vilified often times, while also the high personality of an ex king was offended as he was charged with having enslaved our fleet. The address of the unworthy sailor was much deplored.

The schemes of the Moscow hirelings have to be foiled, who have already filtered into the ranks of our glorious Armed Forces, who wrote pages of fulgent epepee for the unique aim of destroying their effectiveness and of abating their moral.







Reasons for his arrest were:

He had collaborated with the SS

He had been an enemy agent.

He was a former Officer of the Xth. Flotilla MAS.

These reasons were supported by the Allied Security Authorities.

The Commando in Capo Dipartimento Marittimo Basso Tirreno was informed of his arrest on the 10th. June and on the same day applied for ZANFAGNA's surrender to Italian Naval custody and claimed to be acting on the orders of Admiral De Courten, who wished to interrogate ZANFAGNA on an unspecified subject.

After action circulation

The CS ceded to pressure and superior rank of the Italian Naval Authority and surrendered ZANFAGNA on the 13th. June at POGGIOREALE goal, stipulating his eventual return to CS control. It is believed that ZANFAGNA was transferred to Rome.

MEMORANDUM for Admiral WARREN

SUBJECT : ZANFAGNA Marcello.

1. On 7 Dec.44, the following information was circulated to all units of the Italian C.S.
"A reliable source has signalled the following information concerning
ZANFAGNA Marcello, born 16 Aug.22 at NAPLES, address Vico 2 Montecalvario 6, law student and ex-member of the GUF. He is believed to be an enemy agent.
In Sep.43, he followed the Germans to the North and in ROME he broadcast propaganda in favour of the Republican Fascists. He stated that he was an officer of the "M" Battalion."
2. On 19 Jun.44, a confidential source reported that during the German occupation of ROME a certain number of Italians were carrying out intensive intelligence activities on behalf of the Germans, reporting to the latter on anti-nazi and antifascists elements.
ZANFAGNA's name was given as a member of this group of Italians.
3. On 18 Jan.45, the following information was circulated to all C.S. Centre:
"ZANFAGNA Marcello, lieutenant of the "M" Battalion, during the German occupation, was frequently at the Hotel "Continente", meeting place of German SS, Italian GNR officers, and German agents and collaborators.
ZANFAGNA carried out Fascist propaganda and inserted propagandist articles in the newspaper "L'Italia".
He is an ardent fascist and on every occasion, shows that his allegiance is to the Fascist Republic and to its leaders.
ZANFAGNA has already been signalled as a nazi-fascist collaborator by CESANA Enrico, who was arrested in ROME for collaboration with the German SS."
4. On 7 Jun.45, the NAPLES C.S. Centre sent notification to the following of subject's arrest on the same day:
 - Ministero della Guerra S.M.R.E.
 - HQ. 3rd District
 - G+2, P.B.S.
 - 312 Field Security Section.

5. On 10 Jun.45, NAPLES C.S. Centre was approached by Italian Naval Authorities who demanded that subject should be placed in naval custody. The Italian Naval Authorities (Comando di Capo del Dipartimento Marittimo del Basso Tirreno) claimed that they were acting on orders of Admiral DE COURTEN.

Major PECORELLA, O.C. NAPLES C.S. Centre later gave way to pressure and senior rank, released subject to the naval authority and sent the following letter to Allied and Italian headquarters on the same day:

MEMORANDUM for Admiral WARREN

SUBJECT : 808 C.S.Bn

1. The 808 C.S.Bn is the Italian Counter Espionage organization which has its headquarters in ROME and centres in all important towns of Italy.
2. It was constituted by Allied Security in October 1943 from the old Italian SIM, and has since worked in close cooperation with Allied Intelligence.
3. Operationally it comes directly under AFHQ and 15 Army Group and for discipline and administration, under the Italian Ministry of War.
4. All operations (arrests etc.) carried out by the 808 C.S.Bn are coordinated with Allied agencies with whom close liaison is maintained.
5. The 808 C.S.Bn is the only Italian Intelligence organization which is recognized as cooperating with Allied Counter-Intelligence and is the only Italian authority which is empowered to deal with cases of a counter-intelligence nature.
6. In Sep.44, it was represented by Allied Security to Captain CALOSI, present head of SIS (Italian Naval Intelligence) after certain interferences had taken place in work of a counter-intelligence nature, that, in future, the SIS would not handle cases of counter-intelligence but would immediately pass them to the Italian 808 C.S.Bn.
7. The case of ZANFAGNA is an obvious matter for counter-intelligence and since the arrest was made by the 808 C.S.Bn, the Italian Naval headquarters at NAPLES had no authority whatsoever to demand that ZAFAGNA be placed in their custody.

MEMORANDUM

Before the outbreak of the war, the Italian Military Ministries (War - Navy and Air Force) had each their own Intelligence Offices and their C.I. sections.

For the Navy and Air Force, the C.I. sections were charged with the duty of ensuring naval and air C.I. duties.

This fact however, often gave rise to inconveniences and interferences, because of their lack of adequate means as compared with those at the disposal of the Intelligence Office depending from the War Ministry.

Since the beginning of the war, the necessity was felt of unifying the C.I. service, and on 15 Sep.42, the Italian Supreme Command issued orders for the abolition of the Navy and Air Force C.I. Sections and the C.I. Service was exclusively entrusted to the C.I. Section of S.I.M.

After the armistice, the C.I. Section was reconstituted in BRINDISI and was entrusted with C.I. duties in Italian territory, both liberated and that which was to be liberated. It was later included in the British W.E. as the 808 CS Bn and has since carried out C.I. duties under the direction of Allied headquarters in close liaison with parallel Allied agencies.

Subject : Lt. Col. Arturo PINTO (R. Navy)

On September 3rd, 1944, the above mentioned Navy Officer was arrested, after being calumniously denounced by an Italian, by the F.S.S. 412 of Florence, under the charge of having collaborated with the Germans when he was head of the IX Delegation for war production, after the armistice of September 8th 1943.

Three days later, as President of the Association of the Manufacturers of the Florence Province, I sent a collective statement to F.S.S. 412, from which it clearly appeared that when in charge, Lt. Col. Pinto did his best with intelligence, and without chinking about the risk he was running, to save from the Germans all that it was possible to save in the way of men, machinery and raw materials, forming the Florentine industrial power. Among many others, the men who signed the above mentioned statement (which I enclose) can give evidence of his loyal and courageous attitude, which greatly benefited Italy as well as the Cause of the United Nations. They can also supply the best possible evidence and produce the most irrefutable documents.

In spite of this, on September 15th, 1944, Lt. Col. Pinto was interned in the Italian Camp of Padula (Salerno), and it seems he has not yet been released, though war is now over in Italy and in Europe.

As I know that the highest ranking Authorities in the Italian Navy have asked the highest ranking Allied Authorities to liberate Lt. Col. Pinto, I feel it is my duty, as President of the Associations of the Manufacturers of the Florence Province, which owes so much to the said officer, to ask for your personal intervention to have Lt. Col. Pinto liberated at once, to clear up the mistake of which he has been a victim, and do him justice.

I would greatly doubt about the possibilities of human justice if the utmost wasn't done by all concerned to make good the mistake because of which Col. Pinto has been a prisoner for ten months.

Trusting that you will solve without delay this question of elementary justice, I remain.

The undersigned, directors of firms and industrial plants which are among the most important in the Florence Province, state, with full freedom of judgement and assuming complete responsibility for the truth of what they are stating, for what concerns their work and within their knowledge, that Lt. Col. Pinto Arturo, "11 head of the IX Delegation during the period" September 1943 - 12 August 1944, during the absence of the titular of the said Delegation, followed a line of conduct conform to the interests of the nation.

From what they know, the undersigned can give evidence that the above mentioned Head of the IX Delegation made ceaseless and intelligent efforts to save the machinery and equipment, the raw materials and the personnel from the systematic spoliation and destruction of the Germans.

Thanks to his help and work, it has been possible to save from the German Commands part of a valuable industrial patrimony which is now being handed over to the country and to the cause of the Allies; to do this he had to run the gravest risks.

The undersigned are able to prove what they have just said with facts and irrefutable proofs, concerning the relations between the various concerns and the Command of the IX Delegation.

On Sept. the 12th 1945 about 2230 hrs I was driving my M/Cycle Triumph No. 4853645 from MONTE SCABELOGO towards TRANI escorting three British trucks Bedford 3 tonners which empty had to reach TRANI. About a 20 kms before Bari the tyre on my back had burst which forced me to stop and to walk towards TRANI.

Just before GIOVINAZZO always walking with the m/cycle in movement, a civilian car approached dazzling me with the strong beam of its fully lights, when passing by.

Already angry about the lot what had happened, I met later another car which did not understand my signals to switch up its lights which took off my sight.

Because the car kept on fully shining at me I took my pistol out to frighten them, keeping the m/cycle in direction from the right towards the left hand side of the road.

The car stopped and four British Policemen with two civilians jumped to me, of whom one took my pistol up, beating me.

They put then the m/cycle and me into their car and took me up to their HQs.

The pistol was Italian make which I had about four month ago at BOLZANO received from an American soldier, paying lire 1500. His name and camp I am not able to mention because I do not know him.



Reference your SD/260.05 dated 28 March.

1. G-2 section at this HQ have no record of the arrest of the above by Allied Authorities while attempting to cross the line into enemy occupied property but enquiries are being made by them of 15 Army Group. Meanwhile will you please ascertain from the Italian Ministry, if possible, the date and place they believe he was arrested.

2. While in training with SIM at BRINDISI subject was in fact arrested on 13 Jan 45 by F.S.S. on suspicion of being a wanted enemy agent. Suspensions proved unfounded and he had been released by 2 Feb 45 and returned to his unit. The Allied organization which recruited him then recommended his dismissal from SIM's service because his Italian C.O. made an adverse report on him at the time of his arrest.

3. It is possible that since that time subject did in fact attempt to enter EOT. On the other hand there may have been a confusion on the part of the Italians and the arrest they refer to may in fact be that of 13 Jan. If the former turns out to be the case all relevant details will be supplied for the Italians and consideration will be given to his surrender to them. If the latter suggestion proves correct fuller details could be given to the Italians.

Request you kindly approach Allied Authorities concerned to know further details and for him to be handed over to I.R.N. to appear before a Naval Court.






