While it is appreciated that in the event of the closing down of the Royal Naval Base, Messina, the availability of acetylene gas to the local Italian Navy authorities will probably increase, it is requested that the Ministry of Marine may take steps to arrange for the future supply of this gas to Reggio from Italian resources as early as possible.

For some time past the Royal Naval Base at Messina has supplied the Italian Navy with acetylene gas for the two lighthouses at Reggio, at the rate of about five bottles per month.

2. The amount of acetylene gas supplied to the R.N. at Messina is invariably well below the quantities demanded, and at the moment supplies for the Reggio lights are being made from limited stocks held for dockyard requirements.

3. While it is appreciated that the closing down of the R.N. Base, Messina, will probably automatically increase the availability of acetylene gas to the local Italian Naval authorities, it is suggested that the Italian Navy should be requested to arrange for the supply of gas to Reggio from their own resources as early as possible.

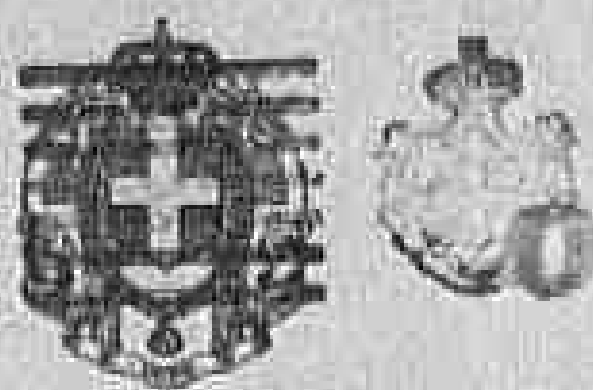

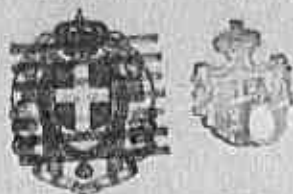
