What is now required is a list, with details, of the plants and equipment which will become available as reparations, after the Italian Government has been allowed its due for the figures quoted above. The precise formula describing such plant is as follows:-

"The factory and total equipment designed for the manufacture of war implements which is not required by the permitted military establishments and is not readily susceptible of conversion to civilian purposes."

SUBJECT: Policy on Italian Munitions Production.

TO: Chief Commissioner  
Allied Commission  
APO 594

1. As directed by the Combined Chiefs of Staff in TAM 638 dated 21 July 1945, AFHQ letter file and subject as above dated 11 February 1945 is rescinded and the following substituted therefor as an interim policy pending the negotiation of a peace treaty when this policy will be reviewed.

2. Pending receipt of a policy directive from Combined Chiefs of Staff, the following interim policy will govern the disposition of Italian industries required for production or repair of arms, munitions or other implements of war. This policy is applicable to all such plants, tools, equipment, facilities and production in such plants, whether State owned or privately owned.

3. NO armaments, munitions or implements of war will be produced except as directed by the US and British armed forces.

4. The Allied Commission will:

a. Encourage the maximum utilization of all arms and munitions plants, tools and equipment essential to the Allied military effort.

b. Encourage the manufacture of equipment and material directed by the Allies as being necessary for the maintenance of the interim Italian Army.

c. Impound all tools and equipment which can produce only prohibited war-like stores, pending decision of possible use in the Allied military effort.

d. Incur operation of industries required for production or repair of arms, munitions or other implements of war only to the extent required by the Allied armed forces and Merchant Marine services. The output of Italian arms or munitions plant will NOT be furnished to the Italian Navy without the prior consent of the Commander in Chief, MEDITERRANEAN.



5. G-3, AFHQ, will be the coordinating section for the study of this problem and will make the necessary directions to the staff sections concerned.



TO : G-5 Section, A.P.H.C.

Reference your AG 388.5/87 dated 2 August 45.

1. In paragraph 4(c) and (e), the Allied Commission is instructed "to impound all tools and equipment which can produce only prohibited war-like stores, pending decision of possible use in the Allied military effort, and to make a survey of Italian war-like stores in arsenals, factories, depots, dumps and in the hands of the Italian armed forces." I would refer you to our letter RA/12.03 dated 22 May 45, in which we indicated that such a survey would require a staff considerably in excess of that available in the Allied Commission.

2. To this opinion I firmly adhere. If these instructions are to be properly carried out a very large staff of technicians and experts would be required. It would in fact necessitate the formation of a Disarmament Commission. There is, however, a further point and that is what object is to be achieved by the survey. Is it to ensure that Italy shall not be in a position to rearm once more to any great extent? Surely this can be achieved by restricting the export to Italy of any raw materials. She has none herself. In the circumstances, therefore, I shall be grateful if further consideration can be given to the instructions in the paragraph referred to above.

3. As regards paragraph 4(a) and (d) this Commission is, as you no doubt are already aware, taking all the necessary action. Some difficulty, however, is found in carrying out paragraph 4(b). It is not known yet whether it is the intention that the interim Italian Army should be supplied exclusively from Italian sources or whether supplies should be made available from the large stocks of Allied arms and equipment that already exist in this country and which it is presumed will not be shipped back to the source of origin. May this point therefore be cleared up as soon as possible.

TO : G-5 Section, A.F.H.Q.

Reference your AG 388.3/087 dated 2 August 45.

1. In paragraph 4(c) and (e) the Allied Commission is instructed "to impound all tools and equipment which can produce only prohibited war-like stores, pending decision of possible use in the Allied military effort, and to make a survey of Italian war-like stores in arsenals, factories, depots, dumps and in the hands of the Italian armed forces." I would refer you to our letter ES/12.03 dated 22 May 45, in which we indicated that such a survey would require a staff considerably in excess of that available in the Allied Commission.
2. To this opinion I firmly adhere. If these instructions are to be properly carried out a very large staff of technicians and experts would be required. It would in fact necessitate the formation of a Disarmament Commission. There is, however, a further point and that is what object is to be achieved by the survey. Is it to ensure that Italy shall not be in a position to rearm once more to any great extent? Surely this can be achieved by restricting the export to Italy of any raw materials. She has none herself. In the circumstances, therefore, I shall be grateful if further consideration can be given to the instructions in the paragraph referred to above.
3. As regards paragraph 4(a) and (d) this Commission is, as you no doubt are already aware, taking all the necessary action. Some difficulty, however, is found in carrying out paragraph 4(b). It is not known yet whether it is the intention that the interim Italian Army should be supplied exclusively from Italian sources or whether supplies should be made available from the large stocks of Allied arms and equipment that already exist in this country and which it is presumed will not be shipped back to the source of origin. May this point therefore be cleared up as soon as possible.

1. It is noted that the two drafts forwarded by reference (a) merely established procedures to be followed in the event Italian plants are found to be engaged in the manufacture of munitions. Paragraph (4) of the draft outlining the procedure to be followed by Allied ~~Head-~~Headquarters specifically states it is not required that investigations be made de novo of plants manufacturing or capable of manufacturing warlike stores. It is not considered that the policy established by Allied Force Headquarters in reference (b) can be effectively implemented until such time as complete information is collected at Allied Commission Headquarters in central files concerning Italian plants which are capable of manufacturing munitions and a survey is made of Italian warlike stores.

2. It is recommended that the Industry Sub-Commission, AC, be made responsible for the compilation of the data required to implement paragraphs 4 (a), (b), (c) and (d) of reference (b) and that the War Materials Disposal Sub-Commission, AC, make the survey of Italian warlike stores required by paragraph 4 (c) of reference (b).

3. It is pointed out that a survey of Italian plants must be made in order to comply with reference (c).

1. It is the policy of AFHQ that no armaments, munitions or implements of war will be produced in Italy except as directed by the US and British Armed forces. This policy is applicable to plants for the production or repair of such warlike stores, whether state or privately owned. (Authority AG 388.3/067 G30-0 of 2 Aug 1945).
2. Recent reports indicate that a certain amount of uncontrolled military construction is being carried out in the North of Italy. AFHQ directs that AC take steps to implement the policy set forth above.
3. Any manufacture of warlike stores which are discovered or reported will be investigated with a view to ascertaining whether they are taking place at the direction of or by permission of the US and British Armed Forces or (in the case of production for the Italian Armed Forces) of the Land, Naval and Air Sub-commission of the Allied Commission.
4. R.Cs and L.Cs will, wherever possible, obtain the cooperation of District commanders in such investigations.
5. If the manufacture concerned is taking place by permission of one of the authorities referred to in para 3 it will be permitted to continue and the circumstances will be reported to this HQ.
6. If the manufacture is not authorized in writing by one of the authorities mentioned in para 3, the work will be stopped at once and the

circumstances reported to this HQ. Such unauthorized manufacture taking place in territory not under AMC control will be referred to this HQ for action.

7. To avoid unnecessary investigations, this HQ will advise RCs and IOs of interested regions of plants now authorized to engage in such manufacturing.

1. It has been reported to this Hq that a certain amount of uncontrolled military construction is being carried out in the North of ITALY. Construction in MILAN of a new type of military aircraft and of 1 man submarines, in TURIN of various firearms has been reported.

2. The question of the extent to which such production is to be permitted in the future is under examination in this Hq. Any manufacture of warlike stores which are discovered or reported to you will be investigated by you with a view to discovering whether they are taking place at the direction of or by permission of the U.S. and British Armed Forces or (in the case of production for the Italian Armed Forces) the Naval Land and Air SCs of the ALLIED COMMISSION. If the manufacture concerned is taking place by permission of one of these authorities, it will be permitted to continue and the circumstances will be reported to this Hq together with a statement as to why the manufacture concerned is necessary. If the manufacture is not authorized in writing by one of the above mentioned authorities, you will instruct the Italian Govt. to cause the manufacture to cease immediately and will report the circumstances to this Hq;




SURVEY OF ITALIAN WARLIKE STORES.

1. Reference is made to Navy Sub-Commission letter NSC/3370 dated 25th August, 1945 on the above subject.
2. While this Sub-Commission agrees in principle with the suggestion contained at para 4 thereof it is not felt that a board, which is likely to be composed almost entirely of junior officers, should be appointed until certain essential points have been clarified. This Sub-Commission, presumably in common with the other Sub-Commissions named, could spare an officer for full-time duty with the board only at the expense of other work and for this reason he could not be of a rank higher than Flying Officer.
3. Before the appointment of the board, therefore, it is strongly recommended that a meeting of the heads of sections in each of the Sub-Commissions dealing with the matter under discussion should be held. The main purpose of this meeting would be to provide an opportunity for a full discussion on a matter on which there is at present considerable confusion in the minds of Sub-Commissions owing to lack of knowledge firstly of the intention of the survey and secondly of its scope. As a result of such a meeting it should be possible to furnish a clear directive to the board proposed in the Navy Sub-Commission's letter under reference, so long as the intention of the A.F.R.Q. directive can clearly be established.
4. It is recommended that the proposed meeting should be held as soon as may be practicable.

1. The Allied Commission was directed in paragraph 4e of reference (a) to make a survey of Italian warlike stores in arsenals, factories, depots, dumps, and in the hands of Italian armed forces. The Economic Section was directed in reference (b) to co-ordinate the survey.

2. The Economic Section in enclosure (A) informed the Navy Sub-Commission that no data had been collected concerning Italian Navy warlike stores and furnished a copy of the Economic Section letter of 12 May 1945 to the Executive Commissioner, pointing out the difficulties inherent in conducting the survey.

3. The Executive Commissioner in reference (c) designated the War Materials Disposal Sub-Commission to co-ordinate the survey. The War Materials Disposal Sub-Commission was requested in reference (d) to indicate the manner in which the survey would be conducted. The Air Forces Sub-Commission in reference (e) requested similar data. No instructions have yet been received.

4. Allied Force Headquarters in reference (f) modified the interim policy established in reference (a) and again directed the Allied Commission to make a survey of Italian warlike stores. In view of the progress which has been made since 11 February 1945 toward carrying out the policy established by Allied Force Headquarters with respect to Italian munitions production, it is evident that the existing organization is not adequate to conduct the survey. It is recommended that a board be appointed, with representatives from the Sub-Commissions indicated below to devote their entire efforts towards conducting the survey:

1. I would refer you to AFHQ letter AG 3883/087 GEG-O of 11 February 1945 and to MAT aigram 23 of 12 March 1945. The question of impounding tools and equipment which can produce only prohibited warlike stores and of impounding stocks of warlike stores that may exist, would require a staff far in excess of that disposed of by this Section. There are insufficient even to make the necessary survey.

2. So far as I know, the MAT aigram referred to above has not been replied to. The matter is one of such importance and urgency, that I think steps should be taken to expedite a reply. If it should be the Allied policy to ensure that Italy shall be rendered incapable of making munitions of war on any scale for some time to come, then the problem of rendering her impotent in this connection would require a very considerable staff, and might well call for the setting up of a Disarmament Sub-Commission.


