Subject: Delivery of Ammunition to Turkish Navy
Destroyers Built in Italy.

1. The Italian Ministry of Foreign Affairs has been requested by the Turkish Government to obtain the necessary permission to deliver the following ammunition to four destroyers of the Turkish Navy, built in Italy:

- a) 5000 shells for guns of 120/50 Ansaldo type, a portion live and a portion for practice.
- b) 5000 cartridge cases for a/m shells, at the global price of U.S. 375.000.

2. This ammunition was manufactured prior to the signing of the Armistice and was not disposed of following the sinking of the units of the Italian Navy to which it was to be delivered. It would complement the supply of ammunition provided by the Italian Naval Yards when the destroyers were originally delivered to the Turkish Government.

3. This proposal has been agreed to in principle by the Italian Ministry of Marine.

4. It is recommended that the request be approved.

The enclosed letter No. 69277/16644.18/19.11 dated 22 January 1947, received from the Italian Undersecretary of State is forwarded for such action as you may deem desirable.

The Commander-in-Chief, Mediterranean Station, under cover of his signal timed 221130 November 1946, to the Admiralty, requested that pressure be brought to bear on the Italian Government through the Foreign Office and the British Ambassador, Rome, observing that as the matter was of a financial nature, neither he nor his representative in Rome have means of forcing the Italian Ministry of Marine to make funds available in Egypt.

The Egyptian representation regarding the removal of the Italian battleships from the Sitter Lakes and referred to in Foreign Office telegram No. 1563 to Cairo also refers to the question.

She was later bombed and burned out. Since then she has broken up in the seas and become a total loss. The Capitaneria di Porto, Pola, reports that the "Partisans" have already removed such scrap metal as was readily available and of any value.

It has come to my knowledge that your Legal Division has inadvertently turned over to the Civil Courts a matter concerning the disputed ownership of the barge "JOYCE", which has been clearly identified as being of French ownership. Legal Division, Allied Military Government, Venezia Giulia's letters VG/AMG/LD/192/3943 dated 12th December 1946 and VG/AMG/LD/192/3944 dated 13th December 1946, together with the Naval Officer-in-Charge, Trieste's letter dated 7th November 1946 addressed to Fonderie Officine Meccaniche Triestine, copy of which is enclosed, refer. The Naval Officer-in-Charge, Trieste has subsequently cancelled his letter referred to above, as a result of the communication received from the Legal Division, Allied Military Government, Venezia Giulia, dated 13th December 1946.

2. I have obtained the views of my legal adviser on the matter, who disagrees with the views expressed in Legal Division, Allied Military Government, Venezia Giulia's letter VG/AMG/LD/192/3944 dated 13th December 1946.

3. From the facts submitted to me, it appears that barge JOYCE with many others was removed from France to Trieste by the Germans in her original state and that they intended to convert her into a transport of troops and material for the North African campaign.

4. If these facts are correct, the present state of the barge, the amount of work carried out on her, the addition to her superstructure, etc., which may have been effected without the consent of the original owner and, either for private profit or on the instructions of the enemy, cannot in any way affect the nationality or origin of the craft nor justify a claim for possession against the original owners.

5. Under the Armistice terms and subsequent agreements, all Allied ships must eventually be returned to their Allied owners, "whether or not

their title may have been transferred as the result of prize court proceedings or otherwise (Art. 15 of Armistice terms and Liberated Ships Memorandum refer).

6. FOMT are in exactly the same position as many other Italian firms in Northern Italy who executed contracts for the Germans or the Fascist Republican Government. They have no claims against the Allies. Furthermore, the interpretation of the Armistice terms does not lie within the jurisdiction of Italian courts. It is up to Allied and not Italian authority to decide whether the barge is an Allied ship or not.

7. FOMT may have a claim for damages against their own Government. They cannot refuse, however, to hand over a ship if and when it has been declared of Allied nationality by Allied authority, whatever the conditions under which this craft came in their possession may have been.

8. It is requested therefore, that you take necessary steps to effect the turnover of the barge in question to the Mission Marine Marchande Francaise without delay, and that you inform me of the date of transfer.

1. At the request of United States Military authorities the Navy Sub-Commission took steps to secure the cooperation of the Italian Naval authorities in the clearance of the Port of Leghorn for reasons of operational necessity. One of the principal obstructions in the harbor is the wreck of the former Yugoslav ship "CATTIAO". An investigation of the possibilities of removing this ship by salvaging it or destroying it, has shown destruction of the hulk to be the most economical and quickest means of disposing of what is in any case a doubtful asset, as indicated by Ministry of Marine letter 3815/46 of 7 December 1946, a copy of which is enclosed.

2. In April 1946 the Yugoslav Delegation to the Advisory Council for Italy advised the Navy Sub-Commission that a rumor to the effect that the Italian Government planned the destruction of the CATTIAO in the interests of clearing Leghorn Harbor had come to their attention. In their letter Br. 472/46 of 4 April 1946 (copy enclosed), strong opposition to any such suggestion was voiced. The Yugoslav Delegation were assured by the Navy Sub-Commission, at that time, that there was no truth in the rumor.

3. In June 1946 the Ministry of Marine requested permission to remove the ship for operational reasons. The views of the Yugoslav Delegation were requested and the reply was again strongly negative as indicated in their letter Br. 922/46 of 28 June 1946, a copy of which is also enclosed herewith.

4. In view of the circumstances indicated in paragraph 1 above and the facts outlined in Ministry of Marine letter 3815/46, of 7 December 1946 it is requested that the approval of the Supreme Allied Commander, may be given for the destruction of the subject vessel to expedite clearance of Leghorn Harbor for reasons of operational necessity, observing that the United States Army remains in military occupation of the port.

After having taken note of your letter NSC/5602, dated 29th October 1946, we inform you herewith of our views on the subject,

1. The fact that the "IDOLATRE" was assigned to the "Compagnia Marittima" by the Transportation Sub-Commission on 27th September 1945 is evidence of the responsibility of the Allied Commission, which should have given orders to the "Compagnia Marittima" for its return as soon as it was known that she was of French ownership. This fact was signified numerous times, and for the first time in the letter of 30th November 1945, of which a copy is enclosed.

2. The fact that the "Compagnia Marittima" has offered to return the "IDOLATRE" to the French Mercantile Marine Mission in Italy, is valueless as its return has not taken place owing to the Allied Commission not having given the necessary orders.

3. It is, nevertheless, a fact that the "IDOLATRE" is still in the hands of the "Compagnia Marittima" which is continuing to make commercial use of the vessel and benefiting from it to the detriment of the French owner. It is therefore evident that the latter has a right to be compensated, at least from the date on which the barge was first claimed to be of French ownership in the letter to the Allied Commission, on 30th November 1945.

1. The discussions on the return of the French barge IDOLATRE have lasted more than a year.

2. Everybody is agreed that the "IDOLAYRE" is French and that it must be returned to France.

3. The reasons which prevent the return are simple financial ones:

- The British demand for repayment of repair work to the craft.
- French demand for compensation for more than a year's use of the IDOLATRE.

4. The "IDOLATRE" continues to work for the benefit of the Italian "Compagnia Marittima" which:

- a) Pays no fee for use of the vessel,
- b) Gains considerably by this fact, and this is detrimental to the French owner.
- c) Uses her for a coastal traffic to which the river barge is not suited and risks causing severe damage to her.

In consideration of this, the French Mercantile Marine Mission in Italy is therefore demanding, in the name of the French Government, that the "IDOLATRE" should be placed at its disposal as soon as possible. The difficulties which are merely financial, will have to be settled in due course.

1. Reference is made to your signals numbers FA 73434 dated 26 November and FA 73649 dated 10 December 1946 on this subject.

2. The Ministry of Marine has informed the Navy Sub-Commission that the regulations for the loading and unloading of dangerous cargoes in the port of Venice state that these operations are to be carried out in the Treporti zone, where ammunition is brought by means of motor vehicles and boats. For small cargoes (under 30 tons) loading may be carried out, provided proper precautions are taken, from Mole A at Marghera, where facilities exist for the direct loading from quayside to ship.

3. The Ministry of Marine, fully realising the difficulty presented by the greater length of land transport to Ancona, which is, however, better adapted and equipped for such work, does not object to the use of the port of Venice for munitions traffic, as indicated in Allied Commission Signal 111240 of December 1946. The necessity is emphasised, however, that at Venice only the Treporti zone should be used for the loading of ammunition, and that at Marghera, should that zone be used, the stay of ships should be as short as possible.

4. This matter was brought to the attention of the Navy Sub-Commission, Allied Commission, by the Italian Ministry of Marine because, it is stated, even though the risk may be reduced to a minimum, the grave consequences of an explosion in the Venice Area in view of the industrial zone of Marghera and the technical, artistic and constructional characteristics of the buildings in Venice, cannot be ignored.

Subject: Allied ships sunk in the port of Augusta

A British ship of unknown type (it appears to be a vessel of over 10,000 tons burden) is lying completely submerged in the port of Augusta, off Port "Vittoria". She was sunk a few days after the occupation of the port, following air bombing which caused the explosion of the cargo which was mainly of ammunition.

It has not been possible to collect any further information about the ship, whose name is not even known.

It appears that the ship is not salvageable and must, therefore, be demolished on the spot.

Another British ship, of the "Empire" class, is lying sunken in the same port, H.M.Z. of Isola Grande, and, according to our information, she was loaded with a cargo of explosives, machinery, motor vehicles, and petrol. She was hit by bombs and appears to have been scuttled by the Allies to prevent her explosion.

It is therefore requested that the Navy Sub Commission should inform us whether the Allied Authorities will provide for the removal of the above 2 ships or whether they are not concerned with the question and leave the salvage in Italian hands.

With reference to your memorandum dated 30th December, 1946, it is confirmed that the "CITTA' DI TRIPOLI" is in nominal hire to the British Government, the requisitioning fees being paid by the Italian Government, in accordance with the Armistice terms. The vessel is employed on the MEDCO service between Malta and Tonon, and as far as is known only service personnel and Government sponsored passengers are carried. The position is similar to that of the "VIA ROMA" and "AUTUNNA" before they were released by the United States Army.

2. Under the British Merchant Shipping Act no British Government Authority can manage a merchant vessel, and the management of the "CITTA' DI TRIPOLI" has been entrusted to the Ellerman Company. This procedure is adopted in the case of all Government operated merchant vessels as opposed to Fleet Auxiliaries.

3. The British Ministry of Transport's Ross office has already referred the Giornale della Sera's article to the Ministry in London in a letter dated 21st December, 1946, and has requested information whether any corrective action should be taken. Despite the inferences of the article the only deliberate mis-statement of fact appears to be that a London businessman "makes an indiscriminate and highly profitable use" of the vessel".

Subject: By Commander Alberto AGOSTINI

1. By Commander Alberto AGOSTINI was not Chief of Staff to ex-Commander D'URBINO. His appointments under Mr. IRGHESSI were the following:

- a) From 19th November 1935, for about 1 month, he was Second-in-Command of the X.M.A.S. Flotilla at La Spezia when it had not yet carried out, or even planned, any sabotage. In this appointment AGOSTINI was concerned with the organisation of the barracks, but after a few days he applied for a transfer as he was not in accord with Mr. IRGHESSI.
- b) Subsequently he carried out the duties of "Secretary General" to the Naval Staff of the Italian Social Republican Navy; he was under the orders of the Chief of Naval Staff for questions regarding "administration", but was never concerned with the "operations" side.

2. According to the reports of the inquiry, AGOSTINI never had any part in operations, sabotage, or spying. Operations were directly ordered by Mr. IRGHESSI, who never sealed himself off AGOSTINI for their execution.

3. D'URBINO, in his capacity of Vice-Chief of Naval Staff to the Italian Social Republican Navy, gave his orders under the heading of "Naval Staff" and sometimes as "X.M.A.S. Flotilla".

In his absence, a few letters from the Naval Staff, also headed "X.M.A.S. Flotilla", were signed "for" or "by direction of" by AGOSTINI. This fact gives the impression - assumed by the allied Authorities - that AGOSTINI is seriously implicated; although none of the letters in the possession of the Ministry of Marine's Commission of Inquiry are of an operational character. The heading "X.M.A.S. Flotilla" was ordered by IRGHESSI, for sentimental reasons, when the communication was addressed to units of the X.M.A.S. Flotilla.

4. AGOSTINI had offered his services because of his desire to safeguard the men and materials of the Italian Navy from German interference. He kept to his object, and did not take part in any operational activity against the allies; on the contrary, he actively assisted the protection of the Italian Navy, resisting and obstructing the interference of the Germans.

1. In reference (a) the Jugoslav Delegation was informed that costs of salvage of Jugoslav ships sunk in Italian waters falls under the category of restitution and therefore cannot be charged to the Italian Government under the armistice terms.

2. It is considered advisable at this time to inform the Jugoslav Delegation that the question of the repair of Jugoslav vessels recovered in Italy also falls under the heading of restitution. If the Jugoslav Government desires vessels being returned to them to be repaired an arrangement must be made with the Italian Government to obtain the necessary Lire for payment of costs incurred by means of a blocked account to be disposed of as determined by the Peace Treaty.
