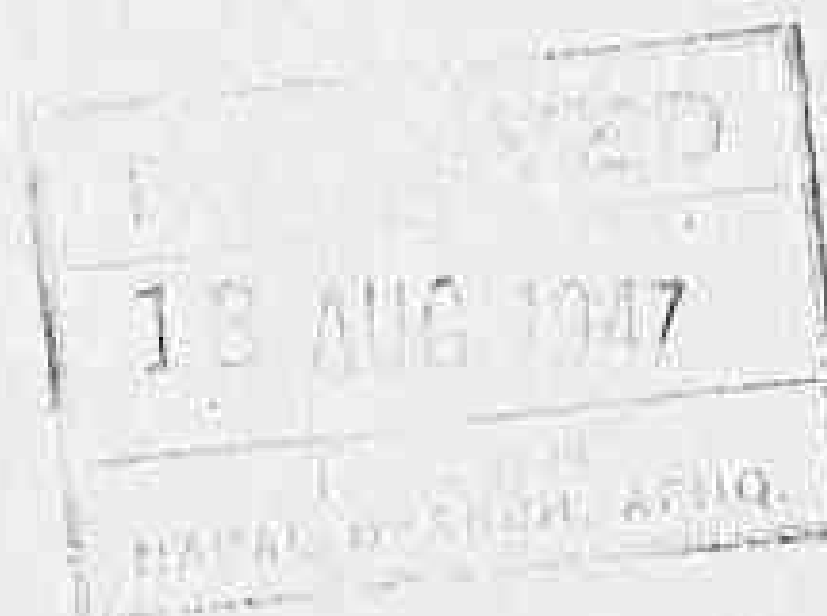
1. Instructions have been given for the N.C.S.O.'s duties at Augusta to be taken over by the Harbour Office, on the 15th August instant.

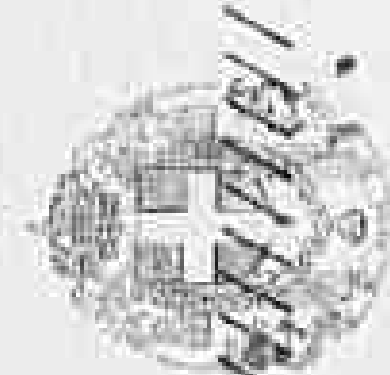
2. All N.C.S.O. duties, which used to be filled by executive officers, are now, therefore, carried out by officers of the Harbourmaster Branch.

Recently, the Navy Sub Commission authorised the transfer of the N.C.Ss. of Catania and Syracuse to their respective Harbourmasters' Departments. It also authorised the reduction to one N.C.S.O. at Ancona and Cagliari.

It is now requested that the possibility should be examined of authorising the reduction or removal of the N.C.S.O.s in the following ports :

Genoa	from 3	to 2
Piombino	" 1	" 0
Naples	" 4	" 3
Civitavecchia	" 1	" 0
Brindisi	" 2	" 1
Palermo	" 2	" 1
S.Antioco	" 1	" 0

In the ports of Piombino, Civitavecchia and S.Antioco, the duties of N.C.S.Os. would be taken over by the Harbourmasters' Departments after a necessary period of instruction between the actual N.C.S.Os. and the Harbourmasters' Departments.

For the ports of Brindisi and Palermo, where the retention of only one N.C.S.O. is requested, the Naval Staff will undertake that an officer of the Harbourmaster Service should become acquainted with N.C.S.O. duties, in order to be able to substitute the N.C.S.O. in case of temporary absence (illness, leave, duty, etc.).

It is also suggested that, on the whole, the employment of Port officers in N.C.S.O. duties presents the undoubted advantage of a greater stability of appointment for the officers concerned.
