1. Refer to Executive Memorandum No. 77. In accordance with instructions from A.F.H.Q., Office of the Assistant Chief of Staff G-2, in letter dated 28 September 1944, ref. B.389.455/7 to this Headquarters the Free Zone is modified.
2. With effect from 1st October 1944 the Free Zone will be extended to include the Provinces of CANTOGRASSO, CHIETI, PESCARA, AQUILA, TERAMO, RIVOLI, FOGGIA, FROSINONE and LITTORIA.
3. The Province of FOGGIA will remain a Restricted Zone.
4. The Restricted Zone will thus extend from the Northern boundaries of the provinces of TERAMO, RIETI and ROMA to the new Rear Army Control Line plus the province of FOGGIA.
