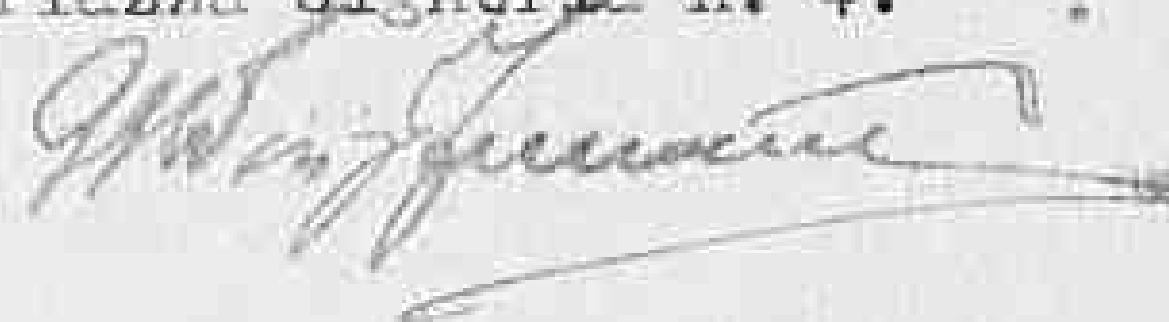

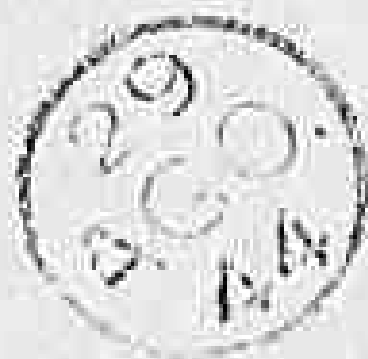

Authority is requested please for the issue of 6 Oil Stoves (Valor) for office space heating. Grounds for the issue of these stoves are as follows:

- 1) That this detachment is occupying only a part of a building for which the only heating arrangement is 'Central Heating' which would use approximately two Tons of Lignite per week.
- 2) The Fuel Scale as laid down in G.H.O. 274 is insufficient for minimum heating, the present strength of five Military Personnel plus 20 Indian giving only 15 lbs per day to heat five large offices with a cubic measurement of approximately 20 000 cubic feet.
- 3) That it is considered impractical for the R.F.A. to fit alternative means of heating as it is a requisitioned building.
- 4) That this detachment is not static and any fixtures would be uneconomical. Valor stoves could be used in any location.

Whilst appreciating the fuel situation it is considered that the stoves requested are essential for the efficient working of this office.

SUBJECT : Stationery and Office Supplies.

1. Reference is made to this Hq letter RVIII/9/2/37 dated 2 Sep 44 (to Provinces only).
2. Due to changes in the method of supply against the bulk demands submitted by this Hq, it has become necessary to revise the method of demands by Provinces and in future indents will be submitted once per month to reach this Hq by the 1st of every month and not twice as heretofore.
3. A supply of the revised indent forms are attached, and P.C.'s are requested to ensure that these are completed intelligently. On several recent Provincial demands, certain items have been requested in quantities which are in excess of the consumption of this entire Hq for 2/3 months. It has also been observed that demands have been repetitions of previous ones, which is an indication that no great thought has been given to their preparation.
4. All items of stationery are scarce and every possible endeavour will be made to economize.
5. The schedule of recurring returns circulated under this Hq letter RVIII/32/38 dated 1 Oct 44 will be amended accordingly.
