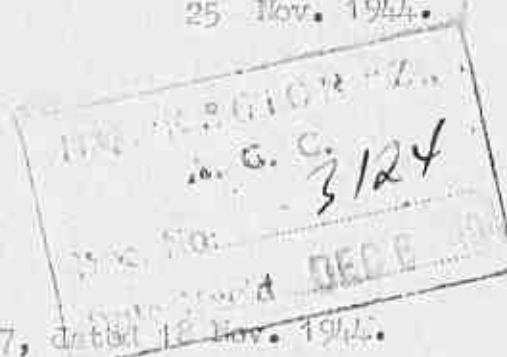

1. Reference you XVII/850.01, Dec. No. 17, dated 18 Nov. 1944.
2. Major V.F.J.C. SNEE, R.A. 4060, (B) desires to have his name put forward, and I have no hesitation in recommending him.
3. Major Snee is, in my opinion, eminently suitable for planning or field work in Austria. He has a good knowledge of the German language, has a thorough knowledge of French. Since he came into this theatre of war he has studied the Italian language, and has made such rapid progress that he carries out the work of a Provincial Officer without an interpreter. He has had lessons in Russian language, is continuing his studies at the moment, and he tells me that by the spring of next year he will have a thorough working knowledge of that language. He has, in fact, a flare for languages.
4. In addition, in pre-war days, Major Snee spent several censored holidays in Austria.
5. Apart from these qualifications, Major Snee has ability of the highest order, and, although I would be extremely sorry to lose him from my Provincial team, I feel that his services could be put to better use in connection with the planning and subsequent occupation of Austria, particularly as he is prepared to serve after the war comes to an end.
