SUBJECT: Direct Reemployment of Patriot Officers.

In reply to the request from Paratroops Branch as to: regarding direct reemployment of officers of the C.V.I. we beg to state the following.

In accordance with present regulations no officers of the Italian Armed Forces can be reemployed without previous scrutiny by the military Ministry concerned, on the prior activity of the officer which must be screened. However, considering the utility deriving from direct reemployment of elements who have the necessary qualifications, this Ministry agrees to the suggestions at the following conditions:

- ✓1. That they should be physically fit;
- ✓2. That they should have belonged to the C.V.I. beyond any possibility of doubt;
- ✓3. That they should not have any precedents of the kind of those enclosed in the attached prospect;
- 4. That they should be placed under the jurisdiction of the I.R.P. appointed by this Ministry, if of same or inferior rank, or that they should collaborate with the above if holding a superior rank;

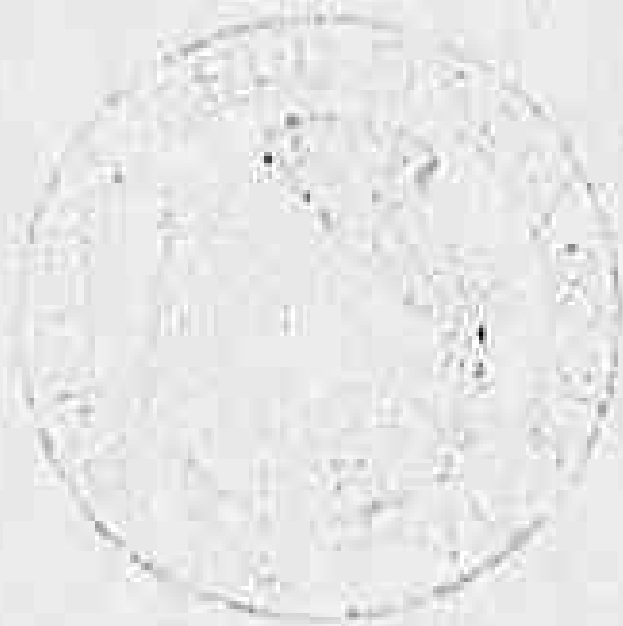
