Reference your letter ref. 53/1/PAT dated 26 December 1944 on the same subject, this Association wishes to point out that to this day no further communication has been received concerning the civil internee at Padula, MANTILE Giustino, of whom the families of the Association request the release after eight months of separation.

We wish to restate the merits of Mantile Giustino. They consist mainly in having helped patriots with subventions, and hiding them from German persecutions. His daughter was engaged to a martyr, S.Ten. Leonida Mucci, murdered by the Germans in Bussi on 14-12-43 together with 9 more patriots. Mantile was a worthy citizen, honest, industrious. Finally he has been indirect and unconscious victim of Fascism by the unfortunate fact that he was once a "squadrista".

The relatives, the widows and the orphans of the Martyrs from Abruzzo, renew a most warm appeal, to the effect that the letter ref. No. CO41/ASS dated 16 December last signed by our President and by all the families of the martyrs and of the patriots should be acknowledged. Also it is requested that pityful health of Mantile aggravated by lack of assistance and by the seasonal bad weather be taken into consideration.

With faith, the relatives of the nazi-fascist victims, thank, etc.

SUBJECT: Internee: Mantile Giustino.

As President of the Associazione Famiglie dei Martiri della Patria e della Libertà, I take the liberty of putting forth an extremely pitiful case: Mr. Giustino MANTILE of this town, has now been interned at 371 P.o.W. Camp at Padula (Italy) charged with having been a "squadrista". The daughter was engaged to S.Ten. Mucci Leonida, executed by the Germans at Bussi on 14 Dec. 1943 together with 9 other patriots. She implores that her father, against whom no charges can be brought, with the exception of having unfortunately been qualified a "squadrista" against his own will and personal convictions, which I can testify as being definitely against fascism, should be released.

Mr. Mantile has helped many partisans and patriots of Chieti including the Chief of the local partisan movement: Dott. Luigi Colazilli who was also executed on 14 Dec. 1942, helping them, affording them shelter and giving them all assistance in the common fight.

Mr. Mantile Giustino is in poor health for posthumous effects of a pleuresy, and should he remain in a concentration camp, the disease would probably deteriorate into T.Bs.

The population of Chieti cares for and appreciate Mr. Mantile and only personal hatreds and jealousies involved him in a nonexistent political guilt.

The undersigned and the families of the martyrs who signed this petition are confident and hopeful that you will do justice to Mr. Mantile, having him released and restored to his family. 41:5

The undersigned assumes full and precise responsibility of the above statements further declarining that Mantile has never profitted in any way of Fascism which brought forth to him only disappointments and sorrows.
