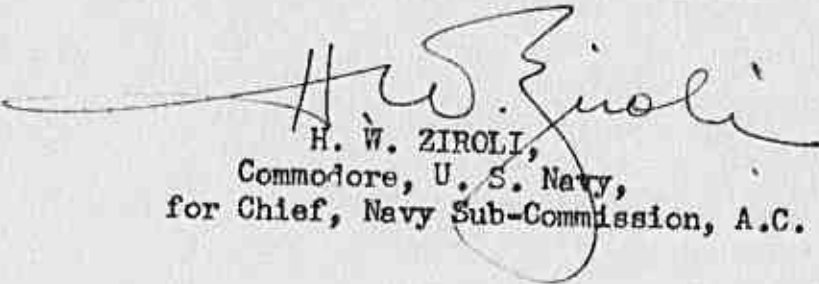

1. On 1st Oct. last I.R.N. personnel Dept. recalled the above Medical Officer for temporary duties. His address is Via della Consulta No. 73, Rome.
2. The "Partito d'Anziane" (Political Party) H.Q. Via Sistina No. 91, Rome, informed this Ministry that this Officer was in the service of Allied Authorities and has been appointed to duties outside Rome in connection with Partisan activities.
3. Under this heading, the Committee of National Liberation mentions that it had forwarded the necessary documentation duly approved by the Allied Command.
4. As the document in question has not reached us and it is necessary to regularize this Officer's position, request you approach Allied Authorities concerned to inform on the matter.
