SUBJECT: MEETING IN C OF S OFFICE 21 Nov 43 ref INFORMATION PERSONNEL

1. Present: Brigadier GUETERBOCK, Colonel FARRON, Colonel PARKMAN, Major BULLOCK.
2. Brigadier GUETERBOCK stated the policy that no former Information Personnel assigned to other duties could be called back to Information as long as Information Personnel was available from existing pools. No personnel may be sent forward to the Mainland Regions unless asked for or ordered up by AFHQ.
3. PRO Personnel must be regarded as requiring entirely different qualifications from Information Personnel. Dominion men will NOT be used as PRO personnel. Knowledge of trends of public opinion is more important than newspaper experience in PRO work. The inference is that PROs should be men of experience in public life.
4. PRO will deal with channels of communication primarily to Britain and United States. Information will deal with material to be disseminated in Italy, through PWB.
5. Major DESMOND and Major BULLOCK remain at AMG HQ as Director and Deputy Director of Information Sub-Commission.
6. Major HIRAM P. CAIN has been selected by General JOYCE as PRO (A). Major L. FIELDEN (B) is to come from Tizi Ouzou as quickly as possible to be interviewed by Brigadier GUETERBOCK as a prospective PRO (B) for General JOYCE.
7. Captain C.J. PARKER (B) will be sent from Tizi Ouzou as soon as possible to replace Major BULLOCK as Information Officer (B) in Region IV. His place in Region IX will remain vacant until a man is available to fill it.
8. Major Randolph LEIGH (A) and Captain L.G. HALDEN (A) will come from Tizi Ouzou as soon as possible to join the Pool at Palermo and gain field experience.
9. Colonel PARKMAN is to order Captain COLEMAN A. HARWELL (A) forward to Region III. as soon as AFHQ can get out a signal to this effect.
10. Information Officer for Region II will be selected and recommended by Major DESMOND and Major BULLOCK as soon as possible.
11. Major BULLOCK is to consult Region I about the situation there with reference to Major JAMES C. HANRAHAN and Captain MAURICE F. NEUFELD.
12. Captain J.P. LEACACOS (A) and Captain S.H. ACHESON remain Information Officers for Regions IV and V respectively.
13. Captain W. HARRY HALLER, JR (A) to remain with BAFU throughout their tour.

14. Vacancies for Information Officers still exist in the following
Regions: VI, VII, VIII, IX.

15. Captain ED SMITH remains for the present in the Palermo Pool.
