1. It is understood that the main party of this Headquarters personnel is to leave Palermo on Thursday, December 9th.
2. Although members of this Sub-Commission have received no orders to move, it is herewith requested that Major Robert W. Desmond, Acting Director of the Sub-Commission; and Captain Edward E. Smith, of the Sub-Commission, not be included in the party that is to move on that date.
3. Reason for this request is that both of the above-mentioned officers are expected to be present in Palermo on or about December 9th for a conference with Mr. Hamilton Smith, of the Psychological Warfare Branch, AFHQ, with which this Sub-Commission maintains liaison. This is by direction of Brigadier Gueterbock and Colonel Rathbone. Mr. Smith was expected to arrive in Palermo on or about December 3, but has been delayed, and reports that he now will arrive on December 9.
4. Unless this Sub-Commission is abolished, or other assignments are received by the above-mentioned officers, prior to the departure of a later party, these officers will be prepared, following conference with Mr. Smith, to move with that later party.
