SUBJECT : Newspaper Distribution in Florence

TO : Sottosegretariato per la Stampa
Via Veneto 58
Rome

1. In view of the fact that A.P.B. and P.W.B. are relinquishing supervision of the press in Toscana Region, a review of the present situation in regards newspaper stocks and distribution will probably prove of value to you for the future.

2. Newspaper is distributed to all the papers and periodicals of Toscana, Umbria, and the Marche by the Banca Nazionale del Lavoro, Firenze. This bank has made an agreement with Cartiere Meridionali for the use of its warehouse in Florence and distributes newspaper from this point. The newspapers and periodicals entitled to receive allocations and their respective quantities are enumerated in attached list.

3. As will be noted in attached list Toscana Region uses at present 97 tons of newspaper in rolls per month and 20 tons of flatbed per month. This figure does not include the Ancona paper "Ricostruzione" which has received a special allocation of 3 tons of newspaper but since it has never received a duly authorized license from A.P.B. has never had a regular allocation.

4. The Società Tipografica Editrice which exercises control over "Giornale del Mattino" and "Nazione del Popolo" of Firenze and "Il Tirreno" of Livorno withdraws on or about the fifteenth of every month a supply of paper for all the papers and periodicals listed in para. 1.

The S.T.E. and particularly its director Commendatore Passigli have proved to be most competent and have co-operated in an exemplary fashion with P.W.B., A.P.B., and this office.

5. On 1 June the situation in regards newsprint stocks will be more or less as follows:

A. S.T.E. will have enough paper on hand for all the journals listed in para 1 for the period 1-15 June.

B. P.W.B. is also expected to turn over to this office approximately 150 tons of paper which is no longer needed by that organization. Since this paper is stored in the Nazione Bldg., Florence this office will turn over this quantity to S.T.E. immediately in order to save transport. This quantity should serve the needs of S.T.E. until 1 August.

C. In the warehouse of the Banca Nazionale del Lavoro there will be on 1 June approximately 200 tons of newsprint which should be sufficient to take care of the needs of Toscana Region until approximately 1 October.

D. Definite figures of quantities to be transferred will be communicated to your office as soon as this office is notified of them by the Banca Nazionale del Lavoro and P.W.B.

TO : Regional Commissioner,
UMBRIA-MARCHE Region.

1. The following is a quotation from your weekly sitrep dated 24 April :

"The approved paper RICOSTRUZIONI in ANCONA suspended publication for lack of paper while 162 papers, including some of purely pornographic nature are being published in ROME."

2. In view of your statement inquiries were made with the following result: Conserec Sub-Commission states that repeated requests have been made to the Provincial Commissioner to make an application to Allied Publications Board for a license for the newspaper RICOSTRUZIONI, newsprint only being supplied on the basis of information furnished in the application to Allied Publications Board. In the absence of an application from your Region, three tons of newsprint were advanced to RICOSTRUZIONI but this action cannot be repeated until a proper application is filed.

3. As regards your statement that 162 papers are being published in ROME, the facts are as follows :

- (a) 24 daily papers have been authorized by the Italian Press Commission, of which 21 are at present publishing.
- (b) 290 periodicals of all types, including weeklies, reviews, technical and other journals, have been granted license, but only 91 are publishing at the moment.

4. No doubt you will take appropriate action with regard to the filing of the application referred to above, and you will also realize the need for checking carefully information included in an allegation of this kind. It is suggested that your informant be apprised of the true facts.

My dear Mr. Prime Minister:

With reference to your letter Number 207, dated 20 March, concerning shipping of newsprint to Sicily, I am informed that consignments of newsprint were made to the Italian Press Commission in the following amounts and on the following dates:

100 tons - 6 March.
100 tons - 9 March.

This newsprint was stored in warehouses in Naples.

In accordance with established procedure concerning imported articles, I.C.E. is responsible for obtaining disposition instructions from the Italian Press Commission for newsprint and for entering shipping bids with the Transportation authorities. I am informed that the Italian Press Commission issued these disposition instructions to I.C.E. about a week ago and that railway bids were then placed. The pressure of rail traffic requires that all bids must be entered two weeks in advance of shipment.

I have just been informed that the following car loads of newsprint were dispatched from Naples on 6 April for Sicily:

2 car loads destined for Catania
2 car loads destined for Palermo
3 car loads destined for Reggio for further

dispatch into Sicily.

SUBJECT: Paper for Victory Editions of Italian Press

TO : Director, Public Relations Branch, HQ AC
(Attn: Mr. G. Stewart Brown)

1. Reference is made to your communication of 2 April 1945, ref. 38/PRE, suggesting that an exceptional allocation of 50 tons of newsprint be furnished to Italian Newspapers for Victory Editions in accordance with the request of Sgr. Libonati, the Sottosegretario per la Stampa.

2. In this connection, there is furnished herewith a copy of a letter of this Subcommittee of 2 April 1945, reference AC/5056/Commerce, in reply to a letter of the Under-Secretary of the Sottosegretariato per la Stampa of 23 March 1945 on the same subject. This letter sets forth the Newsprint position of the Italian Press Commission until the end of the current month, and it is believed that the amounts available are sufficiently large to permit an accumulation of a reserve which would make it possible to bring out a special double-page Victory Edition whenever the final announcement of surrender is made. On the basis of 300 tons per month, the total consumption of all newspapers for one day may be set at 10 tons and not 50 tons as requested, or a little over 3% of the amount available for the remainder of this month. It would seem that a little careful management would make it possible to set aside this reserve without much difficulty.

1. Reference letter to Admiral Stone from S.E. the Undersecretary Libonati of 23 March 1945.
2. The Allied Publications Board has agreed that the Italian Press Commission shall receive in the future 30% of all imported paper stocks up to maximum figure of 300 tons for any one month.
3. Commerce Subcommittee consigned to the Italian Press Commission 200 tons of newsprint on approximately 10 March. Another 250 tons will be transferred to the Italian Government within a week or ten days when the ship carrying the same arrives from America. In other words a total of 450 tons of newsprint will soon have been consigned to the Italian Press Commission which is their full quota for the period 15 March - 1 May.
4. Further stocks cannot be released without authority of the Allied Publications Board nor can special loans be made due to the fact that the Allied Commission has no paper stocks or warehouses at the present except in Florence where newsprint is already in critically short supply.

1. Sig. Libonati saw the Chief Commissioner today and among other things asked for an extraordinary and exceptional allocation of 50 tons of newsprint to be given to the newspapers for victory editions in the event of the fall of Berlin or the possible surrender of Berlin. Sig. Libonati said that the paper could be assigned to his Ministry and he would allocate it according to the circulation of the papers and he would give us every assurance that it would be used only for the above mentioned purpose. The Chief Commissioner said that he did not know what the paper situation was and asked me to get in touch with you to see if this request sounded reasonable and could be granted with our present supply of paper.

2. I believe this is the same request which Sig. Libonati made of you on Saturday except he is now tying it up with the victory celebrations.

3. If the paper is available I suggest we grant this request on an exceptional basis. I would appreciate your decision in as much as the Chief Commissioner asked me to give a reply to Sig. Libonati as soon as possible.

Subject: Issue of paper for "Présence".

1. The French weekly "Présence" is the only French newspaper in Italy. It was, last summer, the Sunday edition of the daily morale newspaper "Patrie". Shortly after the greater part of the French Forces were withdrawn from this theater of operations, "Patrie" ceased its publication and the weekly "Présence" remained as sole source of information for French reading public.
2. "Présence" has a circulation of 10,000 copies and is widely read by French Troops remaining in Italy, Allied Units and Officers and Italian French speaking circles.
3. Because it appeals to such a widespread public it has been difficult to classify "Présence" either completely as a morale paper, or, on the other hand, as a cultural and political paper; therefore the proper Allied organizations have never taken the responsibility of supplying permanently "Présence" with the small amount of paper it requires.
4. Up to now it has been existing through a donation made in September by Lt Colonel Enoch Brown, Chairman of the Newsprint Board.
5. At the present time this issue has been exhausted and "Présence" will have to stop its publication unless it can rapidly be provided with paper.
6. Mr Stewart-Brown, P.R.O., Mr White, Col. Hobsen A.F.H.Q., Lt Col. Monroe, A.F.B. & F.W.B., have been good enough to take a deep interest in this problem and, at the request of Brigadier Lush, have tried to find some way of maintaining "Présence" in existence.
7. In order to avoid to have to take the matter up to the Supreme Command, Lt Col. Monroe has kindly offered to ask in

- ... the name of A.P.B. the Italian Press Commission to help out the French newspaper as a gesture of friendship towards France since the quantities involved are so small (1 Ton a week).
8. Lt Col. Monroe at the meeting of the A.P.B. on Tuesday April 3rd will take up the matter and put this request either through the channel of the Prime Minister or directly to the Italian Press Commission.
 9. It is felt that a letter addressed to the A.P.B. from the Chief Commissioner showing his interest in a general way in this French weekly, and his hope that the Italian Agency will respond favourably to this request would have the greatest possible result.
 10. It is needless to say that Mr Couve de Murville, French Ambassador, Général Le Couteux de Caumont, Commanding French Forces in Italy and the French Representative in the A.C. support this paper strongly and believe that in the French and Allied interest this weekly should be maintained./.

SUBJECT : Newsprint for French paper "Presence"
TO : G. Stewart Brown, Public Relations, A.C.

1. It will be necessary for Brigadier Lush to apply to Allied Publications Board, A.F.H.Q. for allocation of a newsprint supply for this purpose. Such application should be made at the highest possible level.
2. A difficulty in this case is that at no time, so far as I have been able to ascertain, has this paper been supplied officially with newsprint, which may indicate a "Black Market" source hitherto.
3. Newsprint from British sources is issued by A.D.P.S.S. (Printing & Stationery Directorate) Telephone Naples 16171, to whom I applied and I am informed no issue can be made without the authority of Allied Publications Board.
4. Newsprint from United States sources is issued by Q.I. for service papers and by C.W.I. Washington for P.W.B. purposes. For the reason I mentioned in conversation with you, these sources are not favorably inclined to supply, but they need an A.P.B. authority in any case.
5. For these reasons this matter will have to go on to a basis of formal application.

Dear Admiral,

I take the liberty of drawing your kind attention on the situation of the Sicilian press which had to stop its publication for the paper it had been allotted for the period between March 16th and April 15th didn't arrive.

On March 18th, this Undersecretary applied to I.C.E. asking for 20 tons of paper to be allotted to Palermo and 15 to Catania, from copies where this paper was stored.

At the same time, the Ministry of Transport and the Press Office of the Naples Prefecture were asked to see that the above mentioned amount of paper be sent without delay to Sicily. It seems that the Allied authorities in Naples let it be known that they couldn't authorize this paper to be sent from Naples by railway before April 1st.

This Undersecretary took every possible action for this paper to get there in time by truck or by sea. As these attempts had no positive results, and considering the very serious situation in Sicily where the suspension of the publication of the papers caused strong protests, from the local authorities as well as from the Committee for liberation, I felt I had to let you know, for whatever action you will deem advisable to take with the Allied authorities, in Naples, to meet these urgent requirements which might cause more demonstrations of a political character.

1. It will be necessary for Brigadier Lush to apply to Allied Publications Board A.F.H.Q. for allocation of a newsprint supply for this purpose. Such application should be made at the highest possible level.
2. A difficulty in this case is that at no time, so far as I have been able to ascertain, has this paper been supplied officially with newsprint, which may indicate a "Black Market" source hitherto.
3. Newsprint from British sources is issued by A.D.P.S.S. (Printing & Stationery Directorate) Telephone Naples 16171, to whom I applied and I am informed no issue can be made without authority of Allied Publications Board.
4. Newsprint from United States sources is issued by G.M. for service papers and by O.W.L. Washington for P.W.B. purposes. For the reason I mentioned in conversation with you these sources are not favourably inclined to supply, but they need an A.P.B. authority in any case.
5. For these reasons this matter will have to go on to a basis of formal application.

TranslationMemorandum for Admiral Stone

On the 13th, i.e. as soon as the Allied Commission put at the disposal of the Undersecretariat for Press a lot of paper sent from America, the Undersecretary asked for seventy eight tons of paper to be shipped from Naples to Sicily; Fifty tons were to be sent to Palermo and eighteen to Catania.

Since then, the Allied Command of Naples did nothing about the shipping, and only stated it would do what it could, so that it might take place between the 2nd and 8th of April. Meanwhile, Sicilian papers can no longer be published. The publication of the Giornale di Messina has been suspended yesterday.

This causes serious trouble in Sicily. The Italian Government is already being accused of neglecting the interests of Sicily, and this propaganda is greatly prejudicial to the delicate political situation of Sicily.

It would therefore be most advisable to ship the paper from Naples at once, without waiting till April 2nd or even till a later date.

exceeded their authorized circulation figures. On the whole, however, the newspaper consumed by all the Roman dailies corresponds approximately to the quantity assigned to all the Roman papers.

It has been arranged to draw up a new plan for the distribution of the newspaper with a reduction in circulation for some papers and an increase to others. It is considered superfluous for the moment to make a check on unsold returns since, due to shortage of newspaper, circulation figures are considerably below those needed to meet public demand.

The Prefect of Naples has been instructed to institute in that city the same system of control put into force here.

These controls, as already stated, will be effected periodically and if there is any doubt about their efficiency, they will be reinforced by having a finance guard constantly on duty in the printing plants.

As soon as this Office receives information from the Ministry of Industry on the controls being made at the mills, I will advise you.

I believe that the foregoing provides a full answer to the requests made by you and hope, therefore, that you will be able to recommend to Admiral Stone the continuation of paper imports into Italy.

My dear Mr. Prime Minister,

It has recently become apparent that very considerable thefts of imported paper are taking place and that this stolen paper is reaching very high prices in the black market. In order to illustrate the present state of affairs I am sending you a copy of the Minutes of a recent Meeting of the Allied Publications Board which dealt with this subject.

I know that you will feel no less strongly than I do that this not only militates against the freedom of the Italian press but is also a betrayal of the goodwill of the Allies who, while themselves short of paper, are exporting to Italy nearly 1000 tons a month.

I feel compelled to say that unless a machinery for the control of imported paper is established by the Italian Government to the satisfaction of the Allied Publications Board within the next month, I shall feel it my duty to recommend to the Allied authorities a drastic reduction of the paper stocks now imported for territory under Italian jurisdiction.

1. Signor Libonati, Sottosegretario per la Stampa, saw the Chief Commissioner today at 1700 hours regarding the newsprint situation. Signor Libonati asked if the Allied Commission could arrange to "loan" the Italian Press Commission 150 tons of newsprint out of stocks either in its possession or P.W.B.'s, to carry the papers until March 15, by which time, according to their information, newsprint from America might have arrived in Italy.

He added, however, that if such an arrangement were possible it would be contingent upon a satisfactory answer to his letter of 31 January to the Prime Minister. Signor Libonati said a reply was "in preparation".

3. Signor Libonati emphasized that there would be further difficulties for the papers and embarrassment for the government if newsprint could not be loaned to them awaiting the arrival of shipments from the U.S. and the increase in their own paper production.

4. The Chief Commissioner wishes you to give him a recommendation on this proposal of Signor Libonati.

1. I am afraid I absolutely fail to understand MAJOR FIELDEN's attitude on this question. I have discussed the legal status of our requisition in this particular case with Mr. Hermann GOLDSMITH (Procurement Officer) and he in turn discussed it with MAJOR BIGGER, U.S. ARMY, Supply Officer attached to this H.Q. Both these gentlemen are firmly of opinion that this requisition, having been legally carried out through G.4 ROME Area Allied Command, there is no question that Captain WARDLEY was completely within his rights in requisitioning the stocks referred to and that under the terms of the Armistice payment in respect of these stocks is ultimately due from the Italian Government, the stocks having been requisitioned for immediate military operational use.
2. I do not myself see where the Claims and Hirings Section come into the picture since if, as I understand to be the case, such a requisition is within the terms of the Armistice between the Allies and Italy any subsequent negotiations are somewhat outside the scope of Claims and Hirings. It may be that there is some other point in connection with this matter which is not yet clear to me but I must frankly state I can so far see no reason why PWB should pay any money at all in connection with this transaction.
3. Will you please be so kind as to let me know how you yourself view this matter in the light of the foregoing paragraphs?





Dear George:

Signor Libonati was in to see the Chief Commissioner yesterday about the shortage of newsprint. In the course of his conversation he said that the paper situation could be improved if La Cartiere Meridionale, in Isola di Liri, which he said was producing some kind of paper for PWB, could be permitted to use at least a portion of its plant to produce paper for the Italian market.

He did not give any further details and the Admiral said that he would see if PWB still needed the entire plant or what arrangement, if any, might be made. Any information or advice you could give us on this subject would be appreciated.

1. Signor Libonati, Sottosegretario per la Stampa, saw the Chief Commissioner today at 1700 hours regarding the newsprint situation. Signor Libonati asked if the Allied Commission could arrange to "loan" the Italian Press Commission 150 tons of newsprint out of stocks either in its possession or P.W.B.'s, to carry the papers until March 15, by which time, according to their information, newsprint from America might have arrived in Italy.

2. The Chief Commissioner told Signor Libonati that he was not familiar with the details of the paper situation and that he would have to ask for the recommendations of the Commerce Sub-Commission. He added, however, that if such an arrangement were possible it would be contingent upon a satisfactory answer to his letter of 31 January to the Prime Minister. Signor Libonati said a reply was "in preparation".

3. Signor Libonati emphasized that there would be further difficulties for the papers and embarrassment for the government if newsprint could not be loaned to them awaiting the arrival of shipments from the U.S. and the increase in their own paper production.

4. The Chief Commissioner wishes you to give him a recommendation on this proposal of Signor Libonati.

My dear Mr. Prime Minister,

My attention has been called to the decision of the Italian Press Commission temporarily to suspend six newspapers in Rome because of the shortage of newsprint.

In the opinion of the Allied Commission this is not the proper and democratic manner of solving the problem. We feel it would have been better to have made an equitable pro-rata reduction in the allocation of newsprint to all newspapers rather than arbitrarily to suspend certain papers. We believe the papers affected have a legitimate reason to protest against this action.

I very much hope you will give this your personal attention and take steps to have the matter reconsidered at the earliest possible date.

Extract from the Minutes of APC Meeting on Nov. 22nd.

The three contradictory proposals of the Italian Press Commission, on newsprint, are as follows:

One - dated 20 September - requested the general increase in the circulation of the Rome dailies on the list submitted along with the request.

The second proposal, on October 16th, asked instead for one single grant of 50 tons extra, to be divided among specified papers. In additional correspondence, "IL TEMPO" was added and a plan was made that the two "opposition" papers, "LA VOCE REPUBBLICANA" and "ITALIA NUOVA", be given priority in the event that any partial grant was given. The 50 ton proposal left a margin of ten (10) tons to be allocated to papers wanting to extend their circulation to Florence and Sicily.

The third proposal of November 14th, modified the second one by asking that one (1) quintal of paper for each of the eleven Rome dailies be allocated from now until the end of the year, for extra circulation in Florence and Sicily.

Col. Munro reported that, when asked which of these the Italian government desired to be considered, Avv. Rossini named the third. The Board had, thus, to consider conceding a single consignment of 40 tons of newsprint for division among the listed papers, plus one (1) quintal per day for the eleven Rome dailies till the end of the year, which would come to 33 tons, bringing the demand to a total of 73 tons.

Dear Admiral,

The Roman press finds itself in a very difficult situation because of the lack of paper. Some newspapers have exhausted all their supplies; as they cannot find paper on the black market (to which they had resorted during the past months) they are obliged to reduce their circulation, and may have to stop it altogether, having already exhausted their normal allotment. The Roman press is not only supplying the town of Rome, but owing to the improvement in the communications, it also supplies all the Italian part of Ubrin and Abruzzi, and, on a less important scale, other regions too. It is indispensable that the Roman press should also supply the needs of Ubrin and Pescara, for the Florentine papers are rather unimportant and have a small circulation.

For this reason, on October 14th, the National Commission for the Press asked A.P.C. to grant an extra allotment of 50 tons of paper to be divided among the various Roman daily papers. The Under-Secretary for Press and Information also asked on November 29 more tons, needed for the increase of circulation corresponding to a greater diffusion of the Roman press in Pescara and Ubrin. The requested extraordinary allotment to the Roman Press amounted to 80 tons. This would cover the requirements of the press till December 31st. We hope that the increase of the national output will then allow to increase the normal allotments.

I have been told that on November 11th, there were 100,50 tons of paper for newspapers, produced in Italy, in the A.C. depot in Viale Garibaldi 47, and also 19,8 tons of paper produced in this country, requisitioned in Anzio.

Will you kindly see whether it is possible that from this total amount of 120,30 tons, 80 tons should be put at the disposal of the Roman Press as extra allotment; this would enable the press to go on till the end of the year.
