1. Reference your AB/10102/19/25 of 6 February 1945, - above subject.
2. The Military Mission, Argentine Embassy, has long since ceased to function as such, according to available information, and Mr. Diaz is now employed as a clerk.
3. It is not considered by this office that the issue of permits is justified in any of the cases under consideration with the possible exception of (C) PIZZARRO Charles M. who is a genuine Diplomat accredited to the Quirinal according to the list submitted by the Italian Ministry of Foreign Affairs.
4. The other cases are not recommended by this office for the following reasons:-
 - a) BUCOLARE LI Tomaso. It is considered that the Private Secretary of the Ambassador would have the full use of the diplomatic vehicles at the disposal of the Embassy, and that his work could not justify the issue of a permit for a car for his own personal use.
 - b) GIOCE Francisco. This man is at present released on bail charged with travelling without a permit and carrying firearms. This, in itself, would seem a sufficient reason for not issuing a permit.
 - c) and d) DIAZ Adolfo Villalba. For the reasons submitted in paragraph two.
5. The Political Section concurs in the general view that the issue of such permits is not justified.
