The American Embassy in Madrid presents its compliments to the Office of the United States Representative on the Advisory Council for Italy and has the honor to enclose the translated text of a letter from the Charge d'Affaires a.i. of the Royal Italian Embassy in Madrid concerning the desire of the latter Mission to effect the repatriation to Italy of twenty-seven Italian escaped prisoners of war, now in Spanish Morocco, who are said to be anxious to rejoin the ranks of the Royal Italian Army.

In order that the Italian Embassy may be appropriately advised in this regard, the Embassy would appreciate being informed as to the attitude of the competent Allied authorities with respect to the repatriation of the persons in question.

Mr. Ambassador:

The Royal Consul in Tetuan has informed this Royal Embassy of the presence in Spanish Morocco of a certain number of Italian soldiers coming from French Morocco and at present interned in the locality of Ville Sanjurjo: 27 of them cherish feelings of loyalty and have expressed a lively desire to resume as soon as possible their place in the ranks of the Royal Army.

The soldiers in question took refuge in Spanish territory after having escaped from prison camps and therefore one might request the Ministry of Foreign Affairs here to make arrangements in order that they may be handed over to the Royal Authorities for repatriation. However, seeing that all without exception were made prisoners in May, 1943 by the American troops in Tunis and escaped later from concentration camps in French territory, I have the honor to request Your Excellency courteously to let me know in a preliminary way whether objections to their repatriation are perceived on the part of the Allied Authorities.

By way of information I add that the High Commissariat sent a note a few days ago to the Royal Consul in Tetuan concerning the reimbursement to the Spanish Government of the sum of 26,701 pesetas spent by the military authorities of the zone for the maintenance of the soldiers in question from the date of their arrival in Spanish territory until July 31 last.

Please receive, Mr. Ambassador, the expression of my high consideration.

I am to have enclosed your letter to. 6/7/44 of July 2nd and my letter - with apology - to reply to it.

2. We are quite prepared to take over from you reports from Italians for the prosecution of prisoners of war or civilian internees, but it would give us all a lot of trouble if we sent the following considerations in mind.

3. The return of Italians to Italy is in principle undesirable, because they take up valuable shipping space getting home and add to the food problem when they have arrived. The military authorities in this regard only prepared to consider repatriation (a) if the internees or prisoners of war is so ill that his continued stay in camps or Italy, or wherever it is, may result in his death and (b) if he is a high-grade official whose services are ably urgently needed by the Italian Government for the common war effort.

4. In the case of (a) it is for the medical authorities in the field to send a recommendation. In regard (b) it is for the Italian Government to make a request to the Allied Control Commission, not for us (i.e. this High Commission) to take the matter up with the Italian authorities. It seems to me therefore that applications should simply be directed by you either to the Italian Government, who, if they are satisfied that the influence of war or internees will be of use to them, will then raise the question through the proper channel - the Allied Control Commission. We should not take account of them to the Italian Government since our influence must in the nature of things tend to be towards a disengagement in all possible cases rather than towards complete repatriation.

5. As regards the specific cases of the Italian and also mentioned in your letter, I do not feel that we have any grounds for objection.

6. I am sending a copy of this letter to you in the Foreign Office and to all heads of the Allied Control Commission.

7. The return of Italian to Italy is in principle understandable, because they take as valuable flying squad getting home and all to the food problem when they have arrived. The military authorities are therefore only prepared to consider repatriation (a) if the insurance or sickness of war is so all that his continued stay in Italy or wherever it is, may result in his death and (b) if he is a high-grade official whose services are really important needed by the Italian Government for the common war effort.

8. In the case of (a) it is for the medical authorities on the spot to make a recommendation. In regards (b) it is for the Italian Government to make a request to the Allied Central Commission, not for us (i.e. this High Commissioner) to take the matter up with the Italian authorities. It seems to me there-fore that applications should simply be directed by you out to the Italian Government, when, as they are satisfied that the presence of war or sickness will be of use to them, with their taking the question through the proper channel - the Allied Central Commission. We should not make personal claims to the Italian Government since our influence and in the future of things tend to be towards a disconcert in all possible cases rather than towards sympathetic consideration.

9. As regards the specific names of the people and cells mentioned in your letter, I do not feel that we have any grounds for interference.

10. I am sending a copy of this letter to Rome in the foreign office and to Madrid since at the Allied Center I am in the

I, undersigned, Concetta di Scala, living in Naples, at Via Concordia N. 5, mother of 5 sons, owing to the special conditions of my family, take the liberty of exposing you the following facts:

One of my 5 sons, named Michele di Scala, has been serving in the Italian Army as sailor for some years, and was captured as a prisoner of war on January 21st 1941 at Tobruck (Lybia). He is at the present in the Italian Prisoners of War Camp = Camp II = Block 3 = Union of South Africa, prisoner N. 100430. Two other sons of mine were at the same time serving in the Italian Army in Albania and at the time armistice took place they were both captured by the German troops. Of these 2 sons of mine, information received shows that one of them is in Germany as a prisoner of war whilst no news has been received about the other one.

My husband, father of the above mentioned sons of mine, is severely sick and the Doctors taking care of his health state that it will not be long before he dies.

Owing to these circumstances I take the liberty of asking you if you will be good enough as to allow my son Michele di Scala, at the present prisoner of war in South Africa, to return to his family, so that he may assist his father and be of moral comfort and help to him during the last days of his life. My son's return will no doubt also be of great comfort to my family.

I was rather reluctant in writing to you to ask you a favour; but as the same matter has been or is going to be taken up officially with the Allied Control Commission by the Italian military authorities, I feel almost my duty to do something.

My cousin, General Arrigo Grillo, is a P.O.W. at Monticello, Arkansas. I think Marshall Badoglio has already asked for his repatriation. May I add a personal recommendation to such a high one?

My cousin's family situation is rather a tragic one. He does not know yet that his son-in-law was killed in action by the Germans on the battleship "Roma" and that his second daughter's fiancé also died in a submarine accident - and, to make it complete, that his house in Turin has been destroyed.

I would be very grateful if you could do something.

The son of a dear friend of mine is prisoner of war in Kenia since February 1941. He has been sent to East Africa in 1939, and the family have therefore not seen him for the last five years. His name is "Lt. (artillery) Eufisio Martelli" and he is at present based near Nairobi, with the following address: P.O.W. N. 431, Camp 336 B, Post Africa Command.

The family are anxious in the first place to have news about him. In the second place they have asked if there is any possibility of having him included amongst the first batches of P.O.W. who are beginning to be repatriated.

If there is anything you think you can do about the matter, I would be extremely grateful.

1. Reference the list of Italian P.O.W. Officers in the first category of priority to be returned to Italy, (forwarded to you by Lient-Colonel Quin Smith and sent on by you to me). This list is altogether too long for me to hope to press with success for the immediate return to Italy of the Officers named in it.
2. I suggest that Brigadier Duchesne should ask Marshal Messe to let him have to start with a list of approximately 25 Officers in order of priority definitely and urgently required by Marshal Messe for duty in Italy, Sicily or Sardinia with the Italian Army. I think that with any luck I will be able to get most, if not all, of a short list of this size returned to Italy reasonably quickly. Having succeeded with one short list I would then be prepared to submit another one. If, therefore, Marshal Messe likes to give me three or four similar short lists in every case in order of priority I would automatically set to work to do my best to get them repatriated list by list.
3. Please ask Brigadier Duchesne to get on with this right away.
