BADOGGIO INFORMS ME THAT THE COUNCIL OF MINISTERS HAS UNANIMOUSLY APPROVED ITALY'S ADHERENCE TO THE PRINCIPLES OF THE ATLANTIC CHARTER OF ONE FOUR AUGUST ONE NINE FOUR ONE PD HE HAS EXPLAINED THAT AT THE TIME WHEN THE ITALIAN ARMY AS WELL AS THE NAVY AND AIR FORCE ARE ACTIVELY ENGAGED IN THE STRUGGLE AGAINST THE COMMON ENEMY PD TO FREEDOM FROM FATIMA SIGNED JOYCE PD THOSE WHO HAVE FALLEN ALONGSIDE AMERICAN AND BRITISH SOLDIERS CAN HAVE NO GREATER HONOR THAN THAT CONFIRMED BY ITALY'S ADHERENCE TO THOSE PRINCIPLES OF JUSTICE AND EQUALITY UPON WHICH THE HOPES OF ALL FOR A BETTER WORLD ARE BASED PD BADIOGLIO THEREFORE REQUESTS THAT THE WISHES OF THE ITALIAN GOVERNMENT IN THIS RESPECT BE COMMUNICATED TO THE AMERICAN AND BRITISH GOVERNMENTS AND THAT THE LATTER INDICATE WHAT PROCEDURE IS NECESSARY IN ORDER THAT THE ITALIAN GOVERNMENT MAY GIVE EFFECT TO THIS DESIRE PD THE FOREIGN OFFICE HAS FURTHER EXPLAINED THAT WHEREAS IT IS FULLY RECOGNIZED THAT ITALY CANNOT BECOME ONE OF THE UNITED NATIONS CMA THE ITALIAN GOVERNMENT WOULD NEVERTHELESS LIKE TO MAKE FORMAL ACKNOWLEDGE OF ITS DESIRE TO ADHERE TO THE FUNDAMENTAL PRINCIPLES OF THE ATLANTIC CHARTER
