SUBJECT: Remittances from Egypt.

3rd March 1945

TO : Marchese Cittadini

The Ministry's memo. no. 6/1332/573 of Dec. 20th. 1945.

The position is not as stated by the International Red Cross Committee. Italian PoW in Egypt may make remittances to Italy only by authorising the Italian authorities to pay to their families in Italy such sums as may be specified by the PoW from pay accumulated in Italy. There is no transmission of money from Egypt to Italy. Therefore Italian civilians in Egypt cannot yet make remittances to Italy.

The Ministry of Foreign Affairs have replied to our note verbale, at page 2, that as a matter of principle they cannot be held responsible for the expenditure incurred by the Egyptian Government in connection with the evacuation of these refugees from Cyrenaica to Egypt in 1941. They claim that the Italian Government knew nothing of the agreement reached between the Egyptian authorities and the British Consul-General at Alexandria and that moreover there seems to be no precedent of international law whereby they can be expected to re-imburse the expenditure in question.

2. The Italian Government are however prepared to consider the Embassy's request sympathetically as soon as the competent authorities are in a position to examine the question on the spot.

3. We shall have to go carefully in this matter. It seems fairly clear from the concluding paragraph of the Ministry's note that this request on our part may be used in support of the Government's desire to send a representative to Egypt. Personally I think that the Italian request is justified and it is now up to the Foreign Office and the Embassy at Cairo to choose between pressing this claim and yielding to the Italian Government on the question of admitting a representative to Egypt.

MEMORANDUM FOR THE ALLIED CONTROL COMMISSION  
-Political Section-

1° - With their memorandum n. 446 of November 30th, the Italian Ministry for Foreign Affairs, submitted the request that the Allied Governments should be so good as to convey to the Egyptian Government the earnest hope of the Italian Government that, in consideration of the new situation arisen from the conclusion of the armistice and the present Italian status of co-belligerancy, it would have been found possible to suspend all executive measures involving possessions of Italian subject in Egypt and to adjourn to the moment when normal diplomatic relations shall be happily restored, the solution of all problems that had caused the above mentioned measures.

The Italian Government shall be very grateful to be kindly informed what steps in this connection the Allied governments have deemed possible and fit to take, in order to represent the above request to the Egyptian Government, and what attitude the latter have taken on the matter.

2° - The Italian Government shall also be grateful if the Allied Governments can see their way to expressing to the Egyptian Government our confidence that the various other measures of a personal character taken against Italian subjects in Egypt can progressively be suppressed. Reports have been received concerning the very painful situation of Italian internees. The principal cause for the security measures taken against the latter having come to cease, it appears reasonable to expect that all such persons against whom there are no grounds for a different treatment, be restored to their normal life and activities.

In December 19, before you left Brindisi for Cairo, I gave you the translation of a memorandum from the Italian Ministry for Foreign Affairs, enquiring whether the statement issued by Radio ABC was true that the Egyptian authorities were taking action against the property of Italian national companies but, if so, the Egyptian Government could be requested to suspend such measures reserving them to be put up for auction when diplomatic relations were resumed.

I now enclose a further memorandum on the subject. Will you very kindly let me know whether there is anything I can say in reply.

## HEADQUARTERS ALLIED CONTROL COMMISSION

I regret to say that my arts of persuasion were not sufficient to get the Italian Government to agree to the proposal of which you wrote in your letter 11/5/0 of 7 February that we should take over the empty Italian Legation building in Cairo.

Apart from the embarrassment that they would feel in granting us something in Egypt which they had refused to the Americans in London, the reasons quoted are the effect such action would have in Egypt and in liberated Italy and in German occupied Italy. In Egypt and in liberated Italy it would be interpreted as an indication that the resumption of relations with Egypt was to be excluded for an indefinite period in the future. As the Italian colony in Egypt was large, amounting to about 70,000, this would be ascribed to lack of allied confidence in the good faith of the Italian Government and to an express Allied intention to humiliate Italy in defeat. In German occupied Italy such action would also be used by fascist and German propaganda to discredit the Royal Government and might well be made the excuse for the occupation of the British Embassy premises as a reprisal.

I naturally pressed to find if there was not some way round these prestige arguments, for instance by an agreement on our side to vacate immediately the Egyptian Government had decided to resume relations. But it was no good. "Face" was involved and where that comes in, the light of reason is apt to go out. Would you let me know if I should return to the charge and if so with what arguments.

SUBJECT : Supplementary Bread Cards for Egyptian Subjects.

TO : Displaced Persons and Repatriation Sub-Commission.

1. The Egyptian Government have received a report from their Legation at Bern that the Allied Government has recently cancelled the supplementary bread cards held by 20 Egyptian nationals, resident in Rome, on the grounds that Egypt is a neutral country. The Egyptian Government state that these cards were issued to nationals of countries who were at war or who had broken off diplomatic relations with Italy and claim that in view of the fact that the Egyptian Government have broken off diplomatic relations with Italy, these Egyptian nationals should be included in the latter category. In view of the hardship caused by the loss of these bread cards, the Egyptian Government would be grateful if the Commission's decision could be reversed.

2. The British Embassy has asked the Political Section to investigate this matter and the latter would be grateful for material for a reply.
