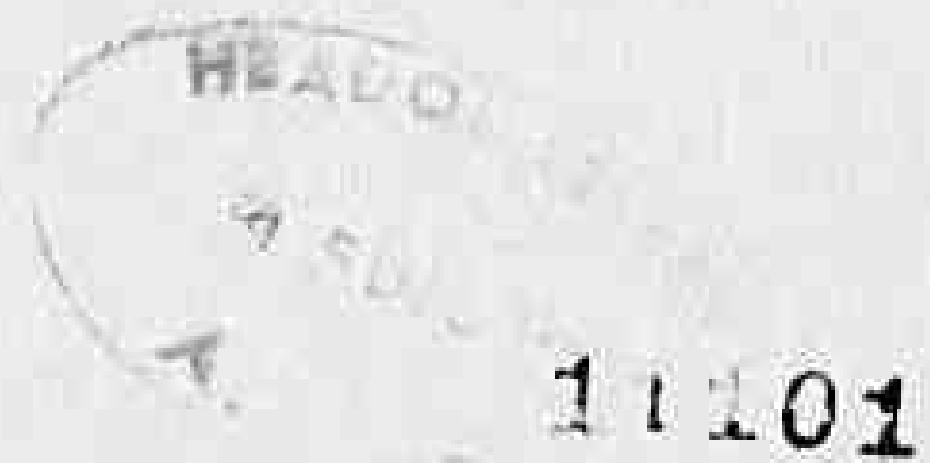
They ask for news, if possible, of their brother Joseph Francis EDWARDS of PHILADELPHIA, who is an Officer in the American Forces. "

1. Reference your No 724 dated 19 Oct 44.
2. CAMAIORE (VIAREGGIO) is in the Province of LUCCA which is under Army Control. SCAO, AMG, Fifth Army was approached as to whether any objections would be made to the proposed movement of ERMETE ZACCONI and his wife to ROME and replied in the negative.
3. ZACCONI was informed on 6 Dec 44, that authority had been received and that transport, which would be specially selected bearing in mind the age of himself and his wife, would be proceeding to ROME on 15 Dec 44. He declined the offer however and requested permission to travel by private means.
4. The PPSO, LUCCA was then approached, but refused to authorize travel by civilian means, as suitable transport was in fact going to ROME, and he considered the use of Petrol for private transportation unjustified.
5. ZACCONI was again approached on 13 Dec 44 and notified of the decision, but once again declined the invitation to travel by the vehicle arranged by this HQ stating that they were too old to travel by military transportation.

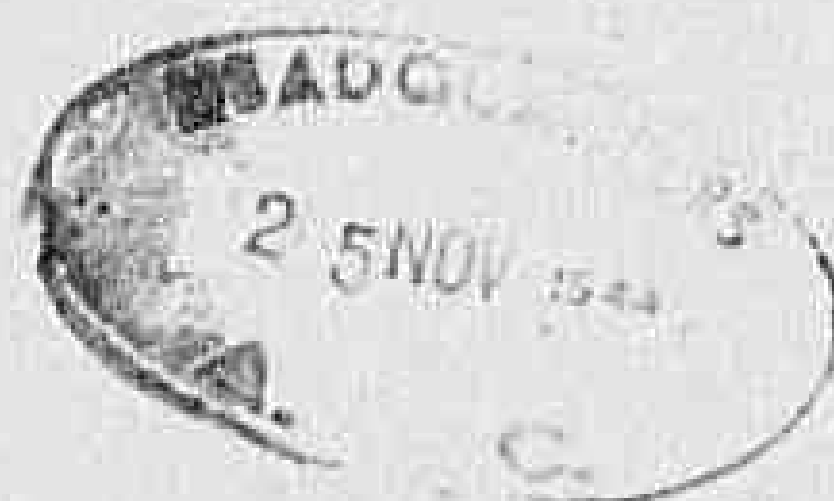

TO : A.M.C. - P.P.S.O. - ROMA.

Reference of required information concerning this Zone's Delegation of Italians Abroad, we inform you that owing to lack of mail service, for several months, it has not been possible to correspond with the Superior Ministry in Rome.

Also before this town's liberation, in compliance with the Prefecture's Orders for Public Office work, we have done regular service, holidays included, and all the staff has shown the utmost goodwill, enduring hard sacrifices and dangers. With vigilance, night and day, it has been possible to avoid snaking by the German soldiers and by the Black Brigade, and we had, from the Provincial Commander, the task to see that the staff was present at work.

It has also been possible to avoid the raking in by German S.S., hiding ourselves in dangerous moments.

The employee Mrs. Palagi Maria had her brother barbarously killed by the Germans, he was ill, and left wife and a child.

The staff has not changed and is as follows:-

- 1) Sardi Conte Carlo - Zone Delegate
- 2) Vanni Avv. Agostino
- 3) Orsi Anna Maria
- 4) Orsi Dina
- 5) Benedetti Giuseppina
- 6) Benedetti Angela
- 7) Palagi Maria
- 8) Del Debbio Aldo.

On Sep 7, two days after the liberation of the town, service has been resumed by the attendant Del Debbio Aldo whom, as an aggregate in the Carabinieri Corps and not adhering to the Republican Guard, passed on to the XI Zone Districts.

The Office has not received the funds for the quarter 1943-44, and the undersigned has had to provide for them himself, also for those of 1944-45 as results from statements given to the Intendenza di Finanza, and from others lying in our Office awaiting to be forwarded to Superior Ministry.

Regarding the wages, in accordance with a Prefecture's order and later those of Allied Commands, they have been regularly paid. Naturally this Office will try to communicate with the Ministry as soon as possible.

Reference Oct 29 as required from that Headquarters, we supply the information concerning the staff of Zone Delegation for Italians Abroad, with residence in town Via Parlamentari - Palazzo Sardi.

The above mentioned office began its activity for the protection of the Emigrants of Lucca Province in 1900 and has always been managed by Conte Carlo Sardi Du Cesare, born in Lucca, 16 Jul 1884, living in Via Parlamentari N. 33.

The above mentioned is of good political and moral behaviour, although contrary to his will, he had been entered in the dissolved Fascist national party from Mar 26, 1924 by the former On. Carlo Scorsone. He never developed any propaganda or held any particular offices.

He has a very good reputation among the population and emigrants in particular, having, especially during the fascist accession facilitated the emigration abroad of extremist elements.

He entertains patriotic feelings and after the notorious 8 of September, although remaining in his office has kept himself away from any political activity, without adhering to the risen "Republican Fascist party".

The Conte Carlo Sardi since 1913 is a member of the Georgian Royal Academy of Florence and is furthermore conferred with the following titles: Knight Commander of the Crown of Italy - Knight of St. Maurice and Lazarus - Knight of the Sovrano Ordine di Malta - Grand Official dell'Ordine della Repubblica di San Marino.

In this Office are furthermore employed the following persons:

1) Ugo Agostino Vanni di Scipione his mother Francesca Panny, born in Lucca Oct 1, 1890; here dwelling Via Cesare Battisti No. 15. He is of good political and moral behaviour and although for opportunism entered the fascist party since 1933, he has never developed any propaganda or had political offices.

He has a good reputation among the population as also among the Office Staff for his diligent and zealous activity.

After the notorious events of Sep. 8 he has kept away from any political activity leaving his Office to avoid the raiding by Nazi-Fascists, for which he ever had adverse feelings.

2) Del Dabbio Aldo di Francesco his mother Morgantini Raffaella, born in Lucca Aug 7, 1907, here dwelling Via S. Leonardo No. 16. Is of good reputation among population and so in the office where he works. Has entered the fascist party for opportunism in 1932 without developing any propaganda, or having any political charges. He is of patriotic sentiment so that after the 8 Sep he enlisted with patriots with whom he helped in the liberation of Lucca.

3) Ossi Anna di Enrico has mother Giambattista Sara, born in Lucca Aug 25, 1903, here dwelling Via Guinigi No. 11, results of good moral and political behaviour, she has never attended to politics and has a very good reputation among the population and in the office ambient. She does not result entered in the fascist party neither

in the republican.

4) Grazianna Di Enrico her mother Giabattari Sara, born in Lucca Aug 8, 1887, here dwelling Via Guinigi No. 13; result of good behaviour in general. She never attended to politics and does not result entered in the fascist party neither in the republican.

5) Benedetti Giuseppina di Giuseppe her mother Marchetti Caterina, born in Pescaglia Feb 11, 1898, dwelling in Lucca Via della Rosa No. 15. She is of good moral and political behaviour. She does not result entered in the fascist party neither in the republican and does not result to have ever been interested in politics.

6) Benedetti Angela di Giuseppe her mother Marchetti Caterina, born in Pescaglia May 26, 1899, dwelling in Lucca Via della Rosa No. 15. She is of regular behaviour in general, and she is well estimated by the population as in the office where she is employed. The above mentioned has never been interested in politics and does not result entered in the fascist party or in the republican.

7) Balagi Maria Maddalena Carlotta di Enea her mother Conti Anna, born in Lucca, May 27, 1915, here living Corso Garibaldi No. 147. She results of good moral and political behaviour. She does not result entered in the fascist or the republican party. Her brother has been murdered by German SS. on Aug 22, 1944.

This Office Manager Conte Carlo Sardi and the staff, explicate their activity as adventitious.

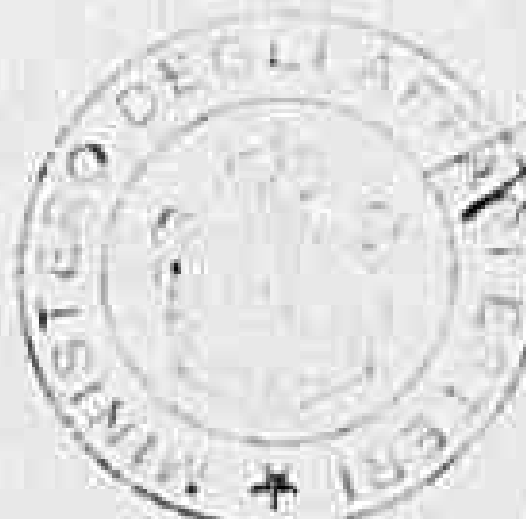

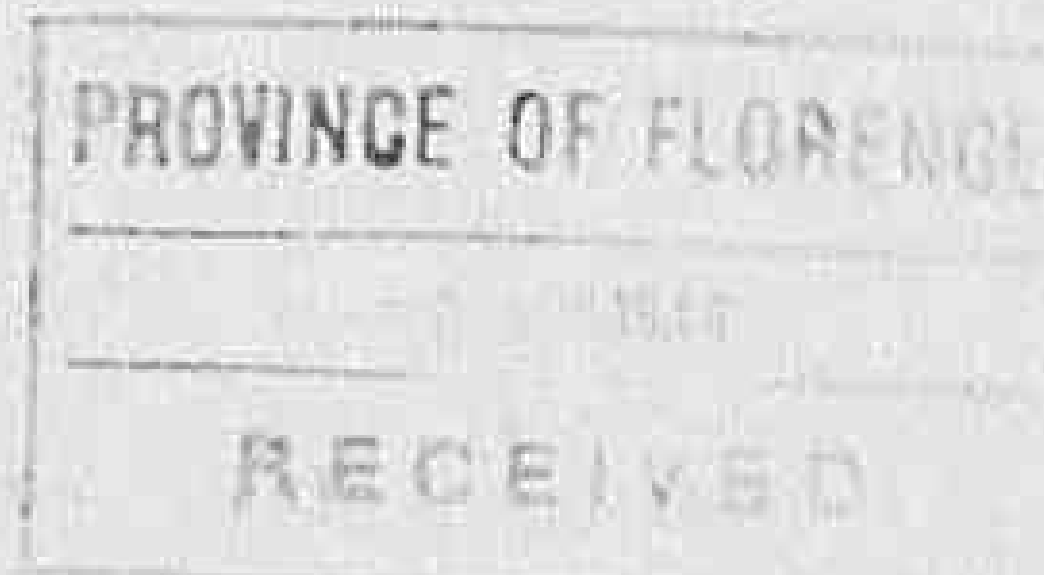

"Count Vincenzo GIUSTINIANI - has been visited in his home in Ponte del Giglio and was found to be in good spirits and health. His home was looted on seven occasions by the German S.S. who stole some of his livestock and personal belongings. His villa is intact although the Germans mined and destroyed the home of one of his contadini."

3. The above information had been sent by the Provincial Commissioner LUCCA province to General Hume who made a special request for it on behalf of the Spanish Embassy to the Holy See.

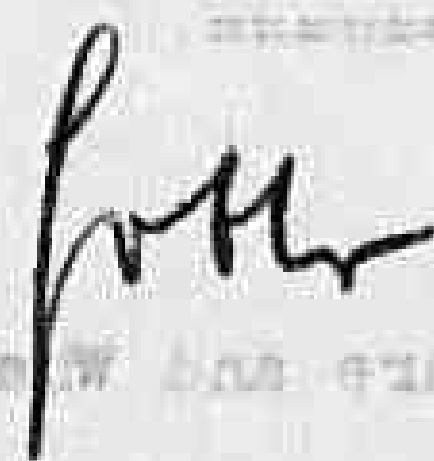

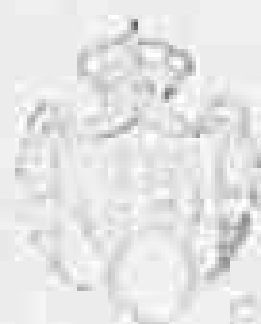
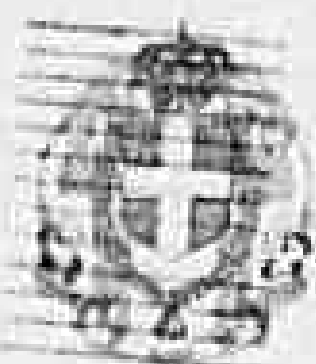

This Ministry has been recently informed that German S.S. have arrested at Urbino the wife of Vice Consul Maurizio De Strobel and her sisters, one of whom, Signora Casilli, is the wife of an official of the Ministry of Italian Africa formerly serving with the Royal Legation in Athens.

The ladies were held in the Urbino ^{gail} as hostages, as their husbands, (De Strobel and Casilli) not having adhered to the Republican Fascist Government, had been interned by the German and Fascist Authorities. Subsequently Signor Casilli managed to escape and joined the resistance movement.

This Ministry believes that, following the liberation of Urbino, the above mentioned ladies must have been freed in the meantime. However, in view of the very severe measures that had been taken against them by the German authorities, it would be much appreciated if the Political Section A.C.C. would be so good as to request the local A.M.G. authorities to furnish some information on them, according them, at the same time, all the assistance they may require.

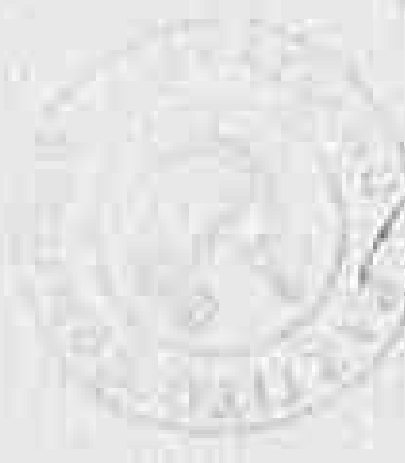

No action had been taken on Tony Rumboldt's letter, because as you will recall from Paragraph 4 we were only asked at that stage for comments. However taking your letter as tantamount to an instruction to act, I spoke to Prunes yesterday saying that we had of course no desire to prevent these Italian residents in Spain trying to get the information that they wanted about their families, but that we did object to direct communications which by-passed Allied Control. He took the point and said that he would see that these questions were in future properly channeled through us and the Italian Foreign Office.

There are a number of Italian residents in Spain who, for fear of reprisals against their families in Italy by the Germans, had not dared to communicate with their families while the enemy still occupied the areas in which the families were.

2. We learn from our Embassy in Madrid that the Italian Embassy there have now sent a telegram to the Italian Charge d'Affaires at the Holy See requesting that information should be obtained about these people. The Italian Embassy were at pains to point out that this step on their part would involve no extra pressure on Allied telegraphic lines since all communications on the subject would pass through the direct Transradio service of the Vatican.

3. But a point which occurs to us is that while this particular enquiry through the Vatican is in itself no doubt harmless enough, direct communications such as this ought to be discouraged in order that the Allied authorities may retain full control over what passes between Italy and Italian Posts abroad.

4. We should be grateful for your comments.

SUBJECT: Whereabouts of Pino Giacobbe di Ruaro.

The request of the Italian Foreign Ministry for information concerning the present whereabouts of Pino Giacobbe di Ruaro, contained in PEB telegram No. 7020 of February 1, 1944, was transmitted to the Department of State by airgram.

The Department has replied that it is communicating the request to the Swiss Legation in Washington, in charge of Italian interests in the United States, with the following comment:

"It is assumed that such information as the Legation may obtain with respect to the whereabouts of Mr. Ruaro will be communicated to the Italian Foreign Ministry through the channels of communication usually employed in connection with the representation by Switzerland of Italian interests in the United States. However, if the Legation so desires, the Department will transmit the Legation's reply through the American Mission at Algiers."

For your information, the Department adds:

"As long as Switzerland continues to represent Italian interests in the United States, such inquiries concerning welfare and whereabouts of Italian subjects in the United States should properly be made through Swiss channels. However, until the Department receives requested information from Bern, it is still uncertain with respect to Swiss Government's representatives in liberated Italy and its channels of communication with Italian Government. Pending clarification, you may continue to transmit through the Department such Italian welfare and whereabouts inquiries. Please keep Department informed of developments."
