I enclose four copies of No. 5 of the Official Gazette of 9 February which contains the long promised decree restoring civil and political rights to Italian citizens of the Jewish race.

Jung told me that he was mainly responsible for this decree which was shown in draft to our Legal Sub-Commission and approved by them. I am thus at least in a position to answer fully the four questions put by the board of Deputies of British Jews and forwarded in your letter 34/150/1 of 2 November.

1. This decree finally abolishes all the Fascist restrictions on Jews.

2. All Italian Jews interned because they were Jews have been released. Indeed orders were given for this immediately Badoglio first came to power on 25 July 1943.

3. Italian Jews now have the same right as any other Italian national to earn a livelihood. A further decree has been passed and signed to help those Italian Jews who were ruined by the previous regime. I enclose a copy. It is to a large extent Jung's handiwork, but it will not be promulgated or put into force until it is safe to do so, that is, until the Germans have been driven out of Italy. There were very few Jews in Southern Italy and in Jung's view it would be a mistake to enforce the decree at the present time when the only probable result would be that the bulk of Italian Jews, who were in German-occupied Italy, would be made to undergo still further suffering and extortion as a revenge. In any communication to the Board of Deputies or other Jewish organisations it is therefore essential that the secret and confidential nature of this information should be emphasized.

4. Italian Jews will be allowed to restore their community life and set up organisations for relief and their other needs in exactly the same way as any other religious body in Italy. Jung said that he had been at pains to ensure that no special privileges should be given to the Jews which were not already enjoyed by other religious sects. I have of course shown this letter to Sam Heber and he has copies of the secret, as well as of the published, decree.

I recently sent you copies of the first issue of the Official Gazette and I now enclose four copies of No. 4/8. Numbers 2 and 3 have not yet come out and will, I am told, only contain a recapitulation of various orders issued up to date on minor administrative matters.

The only decrees to which I need draw your attention are No. 11/8 about the King's title and No. 17/8 laying down that the Under-Secretary of the Interior shall act for the Minister for Italian Africa while the latter's office is in abeyance. As to the former, you will notice that this decree covers all documents and is made effective from 6 September last. As to the latter, the decree I understand is meant simply to provide that your Department should be responsible for the necessary signatures and replies to enquiries about assistance until final decisions are taken. I am advised by Upjohn that he has no objection from the legal point of view and decree 15/8 contains a similar provision in making the Under-Secretary of Finance responsible for the affairs of the ex-Foreign Exchange Ministry.

It has been noted that in the past many decrees have been published in the Gazzetta Ufficiale undertaking to appoint Commissioners and administrative heads for various Italian companies, institutions, etc. with power to act within the entire "liberated" territory i.e. in territory including the AMG zone. In at least one case the Commission has been expressly given power to administer a plant located in AMG territory (Decree of the Chief of Government 19 Feb. 1944 published in G.U. No. 22 of 26 April 1944).

2. It is hardly necessary to point out that none of the aforesaid appointments has any legal effect in AMG territory unless implemented by Executive Commission's endorsement published in the G.U. or otherwise made effective by the competent A.M.C. authority. It is for the individual Subcommissions to bring this fact to the attention of their respective opposite numbers in the Italian Government and to initiate whenever necessary the procedure for implementation in regard to decrees containing appointments which concern their respective field of control.
