My dear Minister De Gasperi:

Allied Force Headquarters has informed the Commission that a detailed study has been made of the question of a relaxation of the restrictions on Italian diplomatic communications which in the past precluded the Italian Government from communicating in cipher undeposited with the Allied Authorities and caused them to disclose the contents of their diplomatic bags to the Allied Authorities before dispatch.

As a result of this study it has been decided that, in principle, secret bag facilities now may be allowed the Italian Government for use in correspondence with their representatives abroad. A precedent has been established in that Ambassador Farchiani was allowed to carry with him a sealed diplomatic pouch when he left Italy for Washington.

However, for security reasons, it was decided that it still is not considered possible to grant the Italian Government undeposited cipher facilities and, in consequence, these facilities must continue to be denied them.

In this connection I may say that when the compromised code A.R. 25 was accepted as a brevity code for communication between Italian Foreign Ministry and Italian Embassy Moscow, it was specifically laid down and accepted by the Ministry that this code should be used for non-confidential messages only.

This restriction appears to have been disregarded in telegrams since sent in this code by the Ambassador in Moscow. Particular reference is made to Moscow-Rome telegram No. 38.

To safeguard security it would be appreciated were the Ministry immediately to submit a suitable system for confidential communication with Moscow. Pending approval of such a system it would appear desirable for the Ministry to instruct Ambassador Quaroni by telegram to arrange for the transmission through Allied channels of any messages whose contents may be confidential.

C. On examination last night we found one serious omission in the "instructions" and several minor points requiring correction. These we shall bring to notice of DALLA ROSA today as requiring rectification before we could commend the system as secure.

D. But we did not think these serious enough to delay submission to AFHQ with request to AFHQ to endorse our favorable opinion (subject to the reserves in C above) quickly in view of the natural wish of Ministero to have CAPANZINI take copies with him.

E. Capt. Duke has taken copies to CASERTA today.

F. We have in our files the Italian version of the attached.



DATE: 6 June 1944

No. 538 - Conforming to the instructions contained in Your Excellency's telegram No. 33 of February 18, I have turned over to the British Embassy all the diplomatic code books held by this Embassy and which were listed in telegram No. 65 to the Ministry. Since these code books were examined by the Germans and the Republicans, in corresponding with the Consulates in Spain and with other Royal Representatives in other neutral countries, I have had to use utmost care in using the codes in such a way as to render indecipherable the communications which this Embassy has to send to these representatives, which, as you are aware, carry out the united policy set by the Royal Ministry. I report now that, complying with a request of the British Embassy, I am continuing to use this same system of cyphering. As regards the military cyphers, as I knew that they had been revealed by the Royal Legation at Lisbon, and as these were not indicated in your Telegram No. 33, I have not been able to turn them over on my own initiative. Please, if you agree, give me the authorization to hand over the non-diplomatic code books, namely the military, commercial and police cyphers.

On receipt of your letter 3/150/3 of the 15th March I duly saw Prunes and told him that we could not agree to the instructions that he proposed about the immobilisation of wireless sets in the Italian Embassy in Spain. I therefore asked that he should send amended instructions requiring that all W/T sets in the Italian Embassy and Consulates should be handed over. This he has now done in telegram No. 83 to the Italian Embassy at Madrid, which was forwarded with memorandum No. 723.C of the 26th March from the Political Section.

2. Having got what the authorities at home required I trust that it will not be misunderstood if I speak a little plainly about this affair. The first point that I would emphasize is that the home authorities have never indicated under exactly what clause of the Armistice I could require this from the Italian Government. As I said in my letter of the 15th February, the Legal Sub Commission were sceptical whether Article 16 was intended to cover this sort of case. This is not a mere debating point. As I have written before, the Germans have made all Europe familiar with the tactics of starting with a little and later pressing for more. We have rightly pilloried these tactics. But if we are to maintain our reputation for straightforward dealing, we should ourselves be scrupulous to see that our demands on a defeated enemy are based on our clear rights under an Armistice or other such arrangement. I recognise that it may be that there is a valid legal argument under the Armistice for insisting that these wireless sets should be delivered to us. If so, I ~~am sorry~~ ^{am sorry} that it was not thought worth while to enable me to use it.

3. There is another aspect which, in fairness to Prunes, I should put right. You said that the Foreign Office had pointed out that Prunes' proposed instructions referred only to sets "belonging to the Embassy" and not to sets in the Italian Consulates. The wording used by Prunes was in fact chosen because we had told him on information provided by C's representative that all the wireless sets from the Consulates had been transferred to the Embassy. Suspicion is right and proper, but in this case unfounded. What is more, I do not understand the reason why the Italian Ambassador could not very well

ascertain personally that such sets had been immobilised and were kept immobilised. If he is so half-witted as to be incapable of such a simple task could we not have arranged for joint inspection at regular intervals? I labour this point because the question of method in controlling the Itelians is an important one. In my experience here, you get far more from them by trusting them a little with the full intention of having a blood-bath if you catch them out, rather than by showing complete lack of confidence all the time. The latter course simply makes them mulish and argumentative about what we mean by co-belligerency.

4. I hope that it will be understood that I make these observations just because we have a high reputation in Italy for just and fair dealing. This is a great asset. That above all is why we should, in my view, always be careful to base our demands on our undoubted rights and be able to show that we are not asking for anything beyond the letter or the spirit.

As you remember these apparatuses had been entrusted to the Ambassador under his personal responsibility.

It is our opinion that by the transfer of both codes and wireless sets we have gone beyond the armistice provisions.

I cannot conceal that, six months after the armistice, this continued feeling of distrust is truly discouraging.

My dear Harold,

I enclose a copy of a report which Armand Lew has sent to me about the unsatisfactory lack of co-operation of Italian intelligence officers in neutral countries. He considers that "very strong pressure" is necessary and should "be exerted as soon as possible in whatever way Algiers thinks best".

2. A good deal of this complaint has been dealt with in your letter No. 730 of February 15th and your telegram No. 43 Resmin Naples of February 18th. I have referred the question of the surrender of the wireless sets in Spain to London and recommended the acceptance of Prunas' point of view. The surrender of the Italian diplomatic cyphers also seems to be proceeding smoothly. I do not therefore suggest that you should take any action on the enclosed report for the time being, unless you see any special reason for doing so.

I have received information that in early October TERRACINI, the Italian M.A. Lisbon, went to Spain to arrange for clandestine wireless communications between himself in Lisbon and the Italian M.A. in Madrid and Berne.

2. I do not yet know what messages were exchanged through these channels, but there is good reason to assume that their purpose and effect was to limit rather than increase the collaboration accorded to us. It was noticeable that, during the early stages of our dealings with Italian Intelligence officers in Lisbon, it was impossible to get them to talk when TERRACINI was present, though they were not entirely reticent when they were alone.

3. For these communications TERRACINI used the S.I.M., wireless apparatus and operator in Lisbon. He did not, however, use the S.I.M. codes, but made ad hoc arrangements while in Madrid for a new and improvised cypher. Though I have at present no knowledge of the procedure in Berne, one may assume that an S.I.M. W/T set was also used at that end. Madrid did not communicate direct with Berne, but sent messages by telephone to Lisbon for transmission by W/T to Switzerland. Communications by this clandestine service were carried on approximately from October 10th to November 20th.

4. D'AJETA, the Charge d'Affaires, admits that he knew of these communications but claims that TERRACINI obtained permission from PRUMAS before the latter left Lisbon. In connexion with the foregoing, BADOLIO might be reminded of the number of occasions on which, subsequent to his general directive of September 19th 1943, he has had to be asked to send specific instructions to individual officers, ordering them to collaborate.

9. I also recommend that it be suggested to BADOLIO that, in order to ensure more effective compliance with his orders in future, he should seize the first suitable opportunity which may arise for taking strong disciplinary action. This recommendation should, I suggest, apply both to the question of the illicit communications mentioned above, and also to any future cases of improper activities or refusals by his representatives to divulge information to the British authorities.

My dear Rome

In a memorandum 3/150/3 of 21 January we were asked to get the Italian Government to send instructions to the Italian Ambassador at Madrid to collect the wireless sets belonging to the consular officers under his superintendance and to surrender them to the nearest British authority. I discussed this with Squadron Leader Johnstone, who decided to get further details and has only recently had a reply confirming that we should go ahead with the Italian authorities.

Frances, whom we both have since seen, said that he wished to make it clear that he would certainly send the required instructions to Madrid if pressed. He did not want it said of him that he was not prepared to collaborate to the limit. But Article 16 of the Armistice simply stated that no Italian radio installations "will transmit until directions for the control of these installations have been procured by the Allied Commander-in-Chief". There was in his mind a difference between the control provided for in this article and the surrender which we now demanded. He presumed that the phrase "the Allied Commander-in-Chief may, at his discretion, take over radio. . . . stations" at the end of the same article was meant to refer to stations such as Bari rather than individual sets.

This was not just shop logic. Italian officials in Spain and elsewhere could only draw one conclusion from an act such as the surrender of these wireless sets, that we have so little confidence in the good faith of the Italian Government that we find it necessary five months after the Armistice to apply the Armistice terms as strictly as or perhaps even more strictly than the terms themselves warrant. Unless we had some special reason for putting forward this requirement, Frances would therefore prefer to telegraph in the following terms to the Italian Ambassador at Madrid:

"No. 27 of February 11. Please collect all wireless telegraph sets including Radiogoniometers belonging to Embassy. Pending further instructions Your Excellency will see to their storage ascertaining personally that they have been immobilised and keeping me and the Allied missions fully informed of action taken. Signed Frances."

As said, however, he did not wish to give any appearance of obstruction and would toe the line, if required. Would you let me know what is decided about this? I have of course discussed this with the Legal Sub-Commission, who are skeptical whether Article 16 was intended to cover this sort of case. You know my strong inclination, which is shared by Sam Heber, that we should not elaborate the terms of the Armistice unless it is vitally necessary to do so. In this instance it seems to me more than doubtful whether it is necessary. If this is right, the question is one of policy. Do we wish to get more or less what we want and yet leave the Italian authorities some face, or do we prefer to press our requirements no matter what?

Could you please keep Fred Reinhardt informed?

We have had some discussion with the G.C. and C.S. about the means by which the Italian Government communicates with their representatives abroad and the means by which the latter communicate with one another, as well as on the rather technical subject of the books and tables used by, or in the possession of, the Italian Government and their diplomatic representatives.

2. As you know, the position at present is that we and the Americans are acting as channels of communication for all messages exchanged between Italian diplomatic missions in neutral countries and the Italian Government but have not been acting as channels for communicating messages between one Italian representative abroad and another. The Italian representatives in Madrid and Lisbon have however been communicating in their own cipher with other Italian representatives in Europe as well as with the Italian representatives at Ankara and Tangier, using ordinary commercial channels. There has been no direct communication between the Italian representatives in Madrid or Lisbon and the Italian representative in Buenos Aires because such messages have to pass through the British or American censorship and are automatically stopped. The messages between Madrid or Lisbon on the one hand and Berlin or the other also go through our censorship but we have been allowing them through after making sure that they were innocuous. We have also been able to read many of the messages exchanged between the missions in Madrid and Lisbon and the other Italian posts as they mostly go by commercial wireless which we can intercept. So far we have not spotted any messages to which any objection could have been taken.

3. When Bob Dixon was in Algiers, Truman asked him whether arrangements could be made for the Italian Government to communicate direct to their missions abroad and in any return to the charge. When he does, we can consider the request afresh but we prefer the existing system which enables us to see Badoglio's instructions to his missions abroad and their answers before they are actually delivered. It seems that the Fascist authorities in the north of Italy and such Italian missions as depend on them in Axis occupied Europe are still using some of the books which were in use before the 1651. As they generally use wireless for transmitting their messages, the G.S. and U.S. are able to obtain them and their task would be made much easier if they could be presented with a complete set of all the cyphers. The question therefore arises how we can best get the Italian Government to have these cyphers handed over to us. It would be possible to quote Article 35 of the Armistice which provides that "The Italian Government will supply all information and provide all documents required by the United Nations", and require them to hand over their cyphers without further explanation. This article was intended to cover cyphers. We have however allowed

such

But they are not normally able completely to read them,

such a long time to elapse that it would be likely to make the wrong impression if we simply invoked this article now without explaining why we wanted the cyphers. We think therefore that the best way to set about it would be to tell the Italian Government quite frankly that we want the cyphers because the possession of them might help us to decipher messages exchanged by the Fascist authorities. If they said that the Fascist authorities would surely not be so foolish as to continue to use cyphers which they must know were compromised from their point of view, we would then have to be still more frank and say that we know that they were still using these cyphers but it should on no account be admitted that we are able to read the messages. I think the correct body to make a communication to the Italian Government of this sort would be the Communications Section of the Control Commission and I refer you in this connexion to TAD 71 of the 7th November containing General guidance from the Combined Civil Affairs Committee in Washington for the use of the Communications Section, the relevant part of which reads as follows:

Paragraph 7. The Italian Government will discontinue use of all codes and cyphers for communication purposes either by itself or by its nationals except under the following conditions: (a) As many copies as may be required of any code or cypher it is proposed to use shall be deposited with the Control Commission etc."

6. Assuming that the Italian Government agree to this request in principle, the odds are that they will be unable to accede to it in Brindisi because Prunas' outfit will not have brought a complete set of books with them from Rome. They may tell us this quite frankly. Alternatively, if they have all the books with them, they may try to satisfy us with only a selection of them. To enable whoever makes the request to judge the value of their answer I enclose a note on the books which the G.C. and C.S. particularly wish to obtain. 7. The first thing is to decide how to make the approach to the Italian Government and then to find out if they can satisfy our demands in Brindisi. If you can let us have a report on both these points by telegram we should be grateful.

If they cannot give us a complete set we should then have to ask them to send instructions to their Missions in Madrid and Lisbon (who, as we know, together possess a complete collection) to hand their sets over to a British or American representative. If it comes to this, the G.C. and C.S. would like to send someone out specially to Madrid and Lisbon to take delivery of, if the Missions have only one set each, to supervise the photostating. The Italian Government would also probably want to entrust their instructions to a special Italian messenger, as they might think twice about obeying instructions of this nature if delivered to them through an Allied channel.

7. The first thing is to decide how to make the approach to the Italian Government and then to find out if they can satisfy our demands in Brindisi. If you can let us have a report on both these points by telegram we should be grateful.

Attached is a list of Code-Books and Sets of Recyphering Tables in use in the Italian Diplomatic and Consular Service at the time of the Armistice.

On Sheet 1 these are listed by the names which each should actually have printed on it as a title or heading and by which it is known to the Italians.

On Sheet 2, corresponding, a more detailed description is given, with the purpose of enabling an officer who might not be acquainted with this material to form some idea whether what may be given to him is what we want.

The list is in order of importance.

Items 1 and 3 are the code and cypher now in use in the Fascist traffic and are of the greatest immediate importance to us.

I would venture to suggest that an officer using this list for checking purposes should avoid letting it be seen by or quoting it to any Italian authority, since the mere fact that we can specify so much would enlighten the Italians, who, we have reason to know, had complete confidence in the security of their cyphers against cryptographic attack.

You will remember our protest against the action of certain of our military authorities in removing our official property from the Villa Gallotti.

There were eight (8) electric fans in the Villa in the cardboard containers in which the Department of State shipped them, new, just before this Consulate General was closed. They were taken from the Villa. I have recovered six (6) of them. One of the remaining two, if not both, was taken by Private Bernard Horkheimer who works for Lieutenant Guarino, ACC Billeting officer.

I make this statement on excellent evidence - (1) he admitted he had taken one in conversation with one of my officers and (2) one was recently seen in his office in ACC here. I have the two empty boxes in which the missing fans were shipped.

The cipher text accompanied by two copies of the plain text version will be sent by hand to the ACC (Adjutant General), where they will be passed to the Political Section (Mr. Reber, or, in his absence, Mr. Caccia), for security inspection.
3. If the result of this inspection be satisfactory, the ciphared message and one copy of the plain text will be sent to ACC Message Center for two purposes.
 - (a) Check of the plain text by a censorship officer (who will be stationed in the Message Center).

With reference to your telegram on the subject, I assure you that cipher codes being used by the Royal Missions abroad are only for communications of a non-confidential nature. All confidential communications are sent through the courtesy of the American and British diplomatic representatives to whom we have recourse."

"Second message. I wish to assure Your Excellency and His Majesty the King that I am leaving for Brindisi by the first possible means. You will be informed as soon as possible of the exact date of my arrival. FRUAS."
