

ESTABLISHMENT - M.T. - I.A.F.

Recently the Italian Air Force in Bari has organised a Military Police Force, part of which is mobile in an endeavour to improve the discipline and security in this area .

2. The only vehicle available at the moment for the mobile patrol is a Jeep. This is a J Class vehicle which is practically a write-off, and is in need of constant repair and spare parts.

3. I was asked if it was possible to find any spares or alternately to change this particular Jeep for one in slightly better condition. I have already pointed out the contents of your AFSC/880/MT dated the 23rd July and have held out little hope of any assistance. Nevertheless I feel that this is a worthy cause as the Police Force indicates an attempt at improvement which is badly needed and I feel that it is possible that some American officers in the Sub Commission might be able to help. Consequently it is requested that the situation be examined with the view to either changing a Jeep or finding spares, and your co-operation is requested.
