NOTICE OF REDUCTION OF I.A.F. OFFICERS

13th in part 1

1. Reference is made to your letter WAC/5837, dated 7th January, 1947.
2. Due to the "Peace Treaty" the Italian Air Force, as well as the other Armed Forces, will have to reduce its strength considerably.

This reduction is at present being carried out in respect of officers holding the rank of Major to Lt. General. In the near future this reduction will be extended to Junior Officers and NCOs.

The procedure for this s/a reduction (the same for all ranks) will be as follows: -
 - a) Examination of the servicemen's behaviour after the 8th of September, 1943;
 - b) Examination of all their military capabilities and their trade qualifications;
3. The Committees in charge of the personnel reduction scheme, referred to in paragraph (2) are: -
 - a) For Lt. Generals, the "Council of Ministers";
 - b) For Officers holding the rank of Colonel thru the rank of Major General the "Superior Committee for Promotions" (Commissione Superiore di Avanzamento);
 - c) For officers holding the rank of Major thru the rank of Lt. Colonel there is a special Committee formed by order of the Air Minister;

- a) For Junior officers and NCOs, the Committees have not yet been formed due to the fact that the reduction in their number has not yet been initiated.

NORMAL METHOD FOR THE EXCLUSION OF OFFICERS (I., A., F.) FROM THE REGULAR SERVICE

Apart from the problem of reducing personnel arising from the situation brought about by the Peace Treaty, the following procedure is the one that even in normal time has always been adopted for the exclusion of I., A., F. Officers from the Regular Service.

This exclusion may be obtained: -

- a) By application of the serviceman;
b) By order issued to the serviceman;

This order, according to Art. no. 38 Bis of the Law 11 March, 1920, no. 397, states that officers not in possession of the necessary qualifications in order to carry out their duties, will have to be excluded from the Regular Service.

This exclusion will be carried out by the following Committees: -

By the "Superior Committee for Promotions" for Officers holding the rank of 2nd Lt. to Lt. Col.;

By the "Council of Ministers" for Officers holding the rank of Col. to General.
