SUBJECT : Blocked Account Ala Italiana.

TO : Regional Commissioner,
Venezia Region. (for R.F.O.)

1. Air Forces Sub Commission has raised with us the status of the bank account and funds of Ala Italiana (formerly Ala Littoria), the controlling organisation of the former civil air lines in Northern Italy and having its head office in Venice.

2. Air Forces Sub Commission are informed:-
- a) that this ente's bank account has been blocked. Would you kindly confirm this and ensure that the account remains blocked;
 - b) that a specific withdrawal of 1½ million lire has been authorised (by Major Monaghan) and that this sum has been withdrawn. Again would you kindly confirm this and let us have a brief report on the circumstances of the application and the reasons for its being granted.

3. The Air Forces Sub Commission representative at Padua, F/O James, is acquainted with the sub commission's views as to the status of the Ala Italiana organisation and perhaps you would be good enough to refer to him any questions relating to its financial requirements etc. before taking action on any further requests that may be submitted.
